3 **Resolution retroactively approving Agreement No. 17-94609, between Department of**  
4 **Public Health, Community Behavioral Health Services, and the California Department of**  
5 **Health Care Services, for the San Francisco Mental Health Plan, for a five year term of**  
6 **July 1, 2017, through June 30, 2022, in the amount of \$0.**

8 WHEREAS, California Welfare and Institutions (W&I) Code, Section 14712 directs the  
9 California Department of Health Care Services (DHCS) to implement and administer Managed  
10 Mental Health Care for Medi-Cal eligible residents through agreements with Mental Health  
11 Plans (MHP) in California counties; and

12 WHEREAS, MHPs are required to provide or arrange for the provision of Specialty  
13 Mental Health Services to beneficiaries in their counties that meet medical necessity criteria,  
14 consistent with the beneficiaries' mental health treatment needs and goals; and

15 WHEREAS, This Mental Health Plan Agreement sets forth the scope of service and  
16 requirements related to the provision of these services for San Francisco County; and

17 WHEREAS, The Department of Public Health, Community Behavioral Health Services  
18 (DPH-CBHS) operates the Mental Health Plan for the City and County of San Francisco; and

19 WHEREAS, The Centers for Medicare and Medicaid Services (CMS) recently  
20 promulgated revisions to the managed care regulations applicable to MHPs; and

21 WHEREAS, CMS is requiring DHCS to develop new agreements with MHPs, effective  
22 July 1, 2017, reflecting these changes as a condition of payment of federal financial  
23 participation (42 C.F.R. 438.802(a)); and

24 WHEREAS, DHCS is requiring the new MHP agreements to take effect retroactively  
25 with a term of July 1, 2017, through June 30, 2022; and

1           WHEREAS, On June 18, 2018, DHCS forwarded Agreement No. 17-94609 for the San  
2           Francisco Mental Health Plan to DPH-CBHS, for the term of July 1, 2017, through June 30,  
3           2022, on file with the Clerk of the Board of Supervisors in File No. 180715, which is hereby  
4           declared to be a part of this resolution as if set forth fully herein; now, therefore, be it

5           RESOLVED, That the DPH-CBHS is hereby authorized to retroactively enter into a  
6           Mental Health Plan Agreement No 17-94609 with DHCS; and, be it

7           FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Director  
8           of DPH-CBHS to sign said agreement on behalf of the City and County of San Francisco; and,  
9           be it

10          FURTHER RESOLVED, That within thirty (30) days of the Mental Health Plan  
11          Agreement being fully executed by all parties, the Director of DPH-CBHS shall provide the  
12          final agreement to the Clerk of the Board for inclusion in File No. 180715.




