16 by appending a Letter of Agreement concerning the City's 2002-2003 budget which provides:
17 (a) for the City to reduce its "pick-up" of the required employee contribution to the retirement
18 system by 2.75% of the employees' compensation effective July 1, 2002 through June 30,
19 2003; (b) a 1% base wage increase effective close of business June 30, 2003 and; (c) a no
20 layoff commitment in fiscal year 2002-2003 for employees represented by participating
21 employee organizations.


