4 **of dedicated service.**

5 WHEREAS, Mabel D. Borjal, a Filipino immigrant, a mother of six and a dutiful wife,  
6 has fruitfully served the City and County of San Francisco for more than 30 years; and

7 WHEREAS, Mabel D. Borjal, a conscientious worker, started her service career with  
8 the City as a Clerk with the Human Services Agency in 1977 and advanced to become an  
9 Eligibility Worker in 1979, working for the marginalized population of San Francisco; and,

10 WHEREAS, Mabel D. Borjal, a thorough worker, unselfishly worked for the Office of the  
11 San Francisco Public Guardian for the last 25 years of her service career as an Estate  
12 Investigator for 11 years and as a Senior Estate investigator for 14 years; and,

14 as an Estate Investigator, managing a wide range of complex and challenging cases requiring

17 support to the staff she supervised while serving as Senior Estate Investigator with the Office  
18 of the Public Guardian, and successfully steered the team through the challenges of a major

21 advancing the Department of Aging and Adult Services Agency's mission of assisting older  
22 adults and adults with disabilities and their families in maximizing self-sufficiency, safety,
