7 **in particular those most impacted by Shelter in Place orders, and those that have not**
8 **accessed state or federal financial programs; and for a loan program which will**
9 **complement and expand existing local, state, and federal initiatives aimed at**
10 **providing relief for small businesses struggling as a result of COVID-19.**
