I live in the Fillmore; have for the past 35+ years. I have lived in St. Francis Square Cooperative for that entire time. I raised my children here, mostly as single parent, and now my grandchildren come here so often that they have friends and birthday parties here with our neighbors. I am very proud to live in a successful Cooperative that is owned and run by the members. There are 299 units, most of these are 3 bedrooms, as our founders wanted families to live and thrive here. We were started by the ILWU (Longshoremen's union) as their African American members could not find housing during the 1950s and early 60s. We were built union, and today, more than 50 years later, all our staff make good livable wages, with benefits. Over half of the current members have lived here for decades, with many of us growing up knowing 4 generations of family members. This longevity and stability give us pride of place and honors our founders and their vision. I have served on numerous committees at the Square as we call it and was elected twice to serve on the Executive Board. Currently, I serve on the Finance Committee. I am a white woman who believes strongly in and who has fought to maintain the vision proclaimed in 1963 that St. Francis Square is Dedicated to the proposition that all races, religions, and beliefs can live together in harmony.

Business and/or professional experience:

I am a union organizer, who has been a member of the same union since 1980, served on many committees within that union, and finally was voted to be the principal officer of the union for 10+ years. I have worked with and for the SF Labor Council for the past 10 years.

I personally understand the importance of affordable housing and the role it can produce for growing a thriving family and community. My experience in working within both a democratically run union and a democratically run cooperative living situation, as given me the broad experience that I have to help implement new, social housing with and for others. Housing should be a right of all San Franciscans, and social housing is one of the best ways to make this a reality.

I also serve on the SOMA Stabilization Committee, enacted by legislation, sponsored by Supervisor Chris Daly, D6, on Rincon Hill that brought in fees for that development. It started in 2005 and the Committee is still a functioning and an active resource to continue to help stabilize the community. Affordable Housing is a critical problem in Soma, and all over the City. The Stabilization Committee is and has been working with SOMCAN and the Community Land Trust, providing resources needed to help stabilize several residential buildings within Soma over the many years of its existence.

Of all the committees and organizations that I have belonged to, I am most proud of being a founding member of Jobs with JusticeSF. JWJsf is a multiracial coalition of both union and community organizations within SF, established 10 years ago. JWJsf believes that workers, from very low and no waged to higher waged, do not lead single issue lives; that we need to make living wages, have access to healthcare, quality public education, affordable housing and a livable climate. One way to ensure this success is providing social housing, cooperative housing as an option.

I am an Asian American and long time advocate for affordable housing. I have worked in San Francisco for over thirty years. In my former position as a tenants rights attorney at the Asian Law Caucus I represented low income tenants in every district of the city with a particular emphasis on representing seniors and tenants of public housing. In my present position at Chinatown Community Development Center my work aims to advance policies that prevent displacement of vulnerable populations and expand affordable housing opportunities citywide.

Policy Analyst and Counsel, Chinatown Community Development Center (2011-present). CCDC is a community based nonprofit housing developer. We own, operate, and develop housing for low income people with the purpose of protecting and building inclusive communities. I have lived in San Francisco's Mission District since 2008, and in the last 13 years, I have seen the rapid change in our neighborhood, driven in large part by insufficient housing to allow people from a range of backgrounds to stay here. This is part of the reason that I undertook a career change to affordable housing. I worked at BRIDGE for three years as a project manager, during which time I managed the rehabilitation of over 500 units of public housing in the Mission and in Bernal Heights, with no displacement, in close partnership with Mission Economic Development Agency and Bernal Heights Neighborhood Center. Currently, I work with affordable housing providers around the Bay Area to help source financing and execute projects involving both new construction and preservation. My experience has allowed me not only the opportunity to understand the diverse perspectives of residents of public and other subsidized housing, but also what is required to purchase, build, and operate it, and what it takes to meet residents' needs.

In addition to my work in the field, I am black, and an immigrant from Trinidad and Tobago, having moved to the United States to attend university. I naturalized in 2012, after 14 years, and have a special sensitivity to the challenges faced by non-citizens, and particularly undocumented people, in gaining housing security. As a parent of two young native San Franciscans, I care deeply that we have a city that can accommodate everyone who wants to live here well into the future, and affordable housing is a missing piece of that equation today.

Business and/or professional experience:

2014-2017: I was a Project Manager at BRIDGE Housing, where I led the rehabilitation of over 500 units of public housing in San Francisco. These projects included senior/disabled housing in the Mission, and family housing in Bernal Heights. These buildings were renovated after years of deferred maintenance, recapitalized with a range of private and public financing sources, and set up with empowered tenant associations. At BRIDGE, I also secured state and local financing for affordable housing projects in San Leandro and Oakland.

2017-2019: I managed Special Projects at FivePoint Communities, which included overseeing design of pilot programs for transportation to Candlestick Point and the Hunters Point Shipyard, as well as research into sustainability modeling for the company's redevelopment.

2019-Present: I have been a self-employed consultant to affordable housing developers on their rehabilitation, new construction, and preservation work in San Francisco and the rest of the Bay Area. This work includes sourcing potential sites, managing design and entitlements, and financial modelling and identifying sources for funding.

As a gay youth activist, I have been consistently and continuously involved in advocacy work since I was 16 years old. Currently 19 years old, I would bring a frequently unrepresented and unheard youth voice to the Housing Stability Fund Oversight Board. During my past three years serving District 5 on the Youth Commission, I have worked with many organizations and bodies that serve and organize youth in San Francisco, particularly in historically underserved Black and brown communities such as the Western Addition and the Mission, to make sure that underrepresented voices are heard at City Hall.

Youth who grow up in the City currently face massive inequities and the ongoing displacement of families who cannot afford to live in San Francisco. Half of all youth experiencing homelessness in San Francisco are LGBTQ+, and yet we continue to fail in our promises to provide low-income supportive housing for Transitional-Aged Youth and families (and affordable and social housing as a viable option for those exiting supportive housing), which we know is an essential part of preventing our most vulnerable populations from losing their homes and their communities in the City. As a member of the Oversight Board, I will continue to make sure that the youth voice is represented in all decisions affecting our future in the City.

Business and/or professional experience:

As a former Board of Supervisors intern to both Supervisors Tang and Brown, as well as serving as Bay Area Student Activists Legislative Director and Youth Commission Legislative Affairs Officer, I have spent the last several years developing an intimate and direct knowledge of state and local legislative advocacy, all while attending high school and college. I am familiar with Board of Supervisors and Planning Commission processes and would bring my experience advocating on policies that impact youth to the Oversight Board, to ensure youth and families are actually being served by Housing Stability Fund programs. I would also bring a knowledge of the state legislative process that will be useful for navigating additional funding sources and advocating for the state to invest in social housing as well.

Additionally, as a linguistics student, I am committed to language access and making sure that non-English-speaking communities are represented in the process of building social housing for working people in San Francisco. Non-English-speaking communities are often excluded from discussions on housing in the City, even though they are disproportionately low-income and should be served by an equitable social housing building program. I will work to make Oversight Board proceedings, and staff-level proceedings at MOHCD in general, as accessible as possible for people whose first language is other than English.

Civic activities:

Since September 2018, I have served as the District 5 representative on the San Francisco Youth Commission, appointed and reappointed by both former Supervisor Brown and Supervisor Preston.

During my three terms, I have been repeatedly elected by my colleagues as Legislative Affairs Officer, leading Youth Commission advocacy at the Board of Supervisors on legislation and the budget. I currently work with community organizations in my district that serve youth, especially in the Western Addition, to provide youth with a voice in the City's budget process via the D5 Youth Budget Needs Questionnaire which resulted in a report to the District Supervisor on how the City can improve service for D5 youth. I have also coordinated the Youth Commission's budget priorities process as LAO for the past three years, and would bring that experience and knowledge of budget advocacy to the Oversight Board, which will need to be creative with funding long-term given the fluctuating nature of transfer tax revenues.

Over the years, I have advocated for the City to meet its commitments to build and acquire more housing for youth and Transitional Aged Youth (TAY) experiencing homelessness, while also working with service providers like Larkin Street Youth Services and youth advocates to identify the areas where the City is failing vulnerable populations, including youth. Housing is a human right, and yet too often the City fails to sufficiently operate even temporary solutions for vulnerable youth (the City's first Navigation Center for TAY is still not open four years after it was promised), let alone permanent solutions like housing. On the Youth Commission, I authored a resolution calling on the City to use the Prop C funds set aside for youth and families to actually build housing for youth and families, and I fully support maximizing public housing on public lands.

The new transfer tax for social housing provides a real opportunity to build housing for families and youth in this City, especially if we listen to these constituents in deciding how to allocate funding. However, we also need to make sure that the City at-large is providing the wraparound services and programs that are needed to make this work: we need to make sure that social housing developments are connected to accessible and affordable transportation, that there are accessible and affordable healthy food options nearby, and much more. This means working with departments such as the SFMTA, SFCTA, HSH, DCYF, and the Sugary Drinks Distributor Tax Advisory Committee, all of which I have worked with and advised over the years as a Youth Commissioner, to cross-coordinate planning and specific projects.

I will bring a deep commitment to outreach and listening to disconnected communities and populations, including youth, so that they are well represented in decisions that affect their ability to live, learn, and work in the City.

I am an Indian immigrant and tenant who lived in San Francisco from June 2016 through December 2018. From 2017 to present, as co-founder of the SF Berniecrats Housing Committee, I have spearheaded a push for Municipal Housing for All with a proposed ballot measure known as the SF Community Housing Act (www.sfcommunity.us). I played a significant role in passing November 2020 Props I and K to make “Municipal Housing for All” a reality, starting with a pilot program.

I understand the instability that immigrants in the U.S. face – in housing and in general. My experiences living in Europe and Singapore have reinforced my view that social housing is necessary for large-scale housing affordability. My work on the Community Housing Act and Nov 2020 Prop K involved extensive discussions across the City with public housing tenants, racial and economic justice advocates, housing and homelessness rights organizations, environmental groups, and labor unions.

Business and/or professional experience

I have a B.S. in Physics from the California Institute of Technology (2012-16) and have worked as a search ranking engineer at Pinterest since 2016. In 2011, I created a free iOS app for the London, UK public bus system called London Bus Buddy, and donated all of the ad revenue to build educational facilities for impoverished children living in the slums of Bhopal, India (my mother’s hometown). At Pinterest, I have helped build a more inclusive search engine to surface under-represented skin tones in search results, alongside my main machine learning projects. In my spare time, I have created two websites to gamify phone banking and volunteering for elections – one in support of Bernie Sanders (BerniePB.com) and one in support of progressive down-ballot candidates and issues (GrassrootsPB.com).

San Francisco's Castro district has become my home, and I strive to be a part of the queer community and the larger San Francisco community in many different ways: personally, professionally, politically, and ethically. I ran for the Board of Directors of SF Pride in 2019, with a strong focus on racial justice, because of police brutality that occurred at the 2019 SF Pride Parade. My advocacy with DefundSFPDNow focuses on SFPD's continued inability to correct the wide disparities in use of force and arrests against people of color, and diverting money from the police to fund social services and programs that promote racial and economic equity. I've also participated in many of the Steering Committee meetings of the Our City Our Home Coalition, after volunteering on the Nov 2018 Prop C campaign, helping to ensure that the living situation of many of our unhoused residents materially improves as a result of dedicated funding towards solving homelessness.

More specifically relevant to the Housing Stability Fund Oversight Board, my political work in the last few years has gravitated towards understanding the housing crisis here in San Francisco and helping find novel ways to fight it: I've been a part of many discussions and meetings surrounding social housing and public housing, which helped develop and improve the text of the San Francisco Community Housing Act (a Public Housing for All program), and Proposition K on the November 2020 ballot, which ultimately passed. Public housing has a long and sordid history, but I believe that with the proper structure and safeguards, public housing is a necessary and underutilized way of promoting housing stability and economic equity among San Francisco residents. Along with my advocacy for redirecting police funds to solve homelessness, my experience demonstrates a commitment to ensuring housing programs in SF are equitable and effective.

I completed my B.S. and M.S. in geology and mathematics at Stanford University, during which time I served as President of the Stanford Alpine Project, led a multi-week geologic field trip to Iceland, and was editor of two field guides to Iceland and India. After graduating, I worked as a software engineer at a number of different corporations. I transitioned to working in management at the most recent two companies I worked for, OpenTable and Dozuki. At OpenTable, I was one of the main authors and organizers who wrote and delivered an open letter to the CEO, signed by ~10% of employees at the time, asking for a stronger commitment to diversity efforts.

Civic Activities:

Since moving to San Francisco in 2009, I have consistently worked to give back to the community I live in. I've served as an Elections Inspector for 12 elections, in various precincts ranging from the Castro, the Mission, and West Portal. As the COVID-19 pandemic surged all across the world starting in March 2020, I have volunteered my time with UCSF at many COVID-19 testing events across the Bay Area — including the Bayview, Tenderloin, and Fruitvale neighborhoods — providing support to allow researchers to study the way the virus spreads throughout our local community and to find more effective ways to combat it. I am also currently serving as a member of the SF Civil Grand Jury during its 2020-2021 term.

In the political sphere, I volunteered for the Proposition C campaign in Nov 2018, a ballot measure designed to help unhoused people. I was co-author and campaign volunteer for both the San Francisco Community Housing Act from 2018-2020 and Proposition K in Nov 2020. Finally, I am active in a number of local political groups, including DefundSFPDNow, the Berniecrats, and Democratic Socialists of America, which participate in many mutual aid and advocacy campaigns helping to promote racial justice and progressive causes.



Board Qualifications:

The Housing Stability Fund Oversight Board (the "Board") was established to provide oversight for the Housing Stability Program Fund by making recommendations and providing guidance for the use of the Housing Stability Program Fund for Social Housing Developments, including, but not limited to, the acquisition of land and/or improvements, preservation, development, rehabilitation, construction operation, loans, grants, and other eligible uses determined by the Mayor's Office of Housing and Community Development (MOHCD), and as included in any Housing Stability Fund regulations.

There are a total of 11 voting members: 10 appointed by the Board of Supervisors and, 1 appointed by the Director of MOHCD:

- Seats 1 and 2 shall be held by persons who are residents of Social Housing Developments, as defined in Section 10.100-78 of the Administrative Code, as amended from time to time to be appointed by the Board of Supervisors.
- Seats 3 and 4 shall be held by persons with experience owning, operating, or developing Social Housing Developments, as defined in Section 10.100-78 of the Administrative Code, to be appointed by the Board of Supervisors.
- Seats 5 and 6 shall be held by persons with legal, academic, or financing expertise regarding affordable housing creation and policy, to be appointed by the Board of Supervisors.
- Seat 7 shall be held by a person with experience or expertise in advocacy on behalf of tenants or residents of affordable housing, to be appointed by the Board of Supervisors.
- Seat 8 shall be held by a person with experience or expertise in the organized labor community,

to be appointed by the Board of Supervisors.

- Seat 9 shall be held by an employee of the Mayor's Office of Housing and Community Development (MOHCD), to be appointed by the Director of MOHCD.
- Seats 10 and 11 shall be held by any resident of San Francisco with a demonstrated commitment to affordable housing and to racial and economic equity, to be appointed by the Board of Supervisors.

Members shall serve for four-year terms and may remain on the Board for a maximum of two full terms.

The Mayor's Office of Housing and Community Development shall provide administrative and clerical support.
