7 WHEREAS, The Bland Family Foundation provides grants for Historic Preservation  
8 and Urban Planning; and

9 WHEREAS, These grant funds can be used for program development and support,  
10 equipment and educational assistance; and,

11 WHEREAS, The Municipal Transportation Agency (MTA) will use these grant funds for  
12 the purchase of equipment required to preserve and conserve the historic photo collection of  
13 the Municipal Railway; and,

14 WHEREAS, The MTA is eligible to receive grant funds from the Bland Family  
15 Foundation; and

16 WHEREAS, There is no allowance for indirect costs; and

17 WHEREAS, The grant does not require an ASO amendment; and

18 WHEREAS, No local share of project costs is required; now, therefore, be it

19 RESOLVED, That the MTA is authorized to accept and expend \$10,371 in Bland  
20 Family Foundation grant funds to preserve and conserve their historic photo collection; and,  
21 be it

22 FURTHER RESOLVED, That the Board of Supervisors waives inclusion of indirect  
23 costs in the grant budget; and, be it

24 FURTHER RESOLVED, That the MTA is authorized to execute any and all agreements  
25 necessary to complete transfer of the funds.




