13 WHEREAS, the Fire Department proposes to maximize use of available grant funds on
14 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

15 RESOLVED, That Board of Supervisors hereby waives inclusion of indirect costs in the
16 grant budget; and, be it

17 FURTHER RESOLVED, that the SFFD is hereby authorized to retroactively accept and
18 expend a grant in the amount of \$110,569 from CNCS.


