**Ordinance authorizing settlement of remaining claims in the lawsuit filed by various plaintiffs against the City and County of San Francisco for \$1,748,840.74; the lawsuit was filed on January 31, 2005, in San Francisco Superior Court, Case No. 436930; entitled Jane Martin, et al., v. City and County of San Francisco, et al**

Be it ordained by the People of the City and County of San Francisco:

Section 1. The City Attorney is hereby authorized to settle the remaining claims by the 32 plaintiffs listed in Attachment A in the action entitled "Jane Martin, et al., v. City and County of San Francisco, et al., San Francisco Superior Court, Court No. 436930 by the payment of a total of \$1,748,840.74, representing the claim for interest on diminution of property values, interest on property damage, and attorney's fees, in the amount per plaintiff as set forth on Attachment A.

Section 2. The above-named action was filed in San Francisco Superior Court on January 31, 2005, and the following parties were named in the lawsuit: All plaintiffs listed on Attachment A; and defendant City and County of San Francisco.
