3 Resolution Commending Mr. Carl Anthony For his exemplary
4 accomplishments and invaluable contributions to the citizens of the
5 nine counties of the San Francisco Bay Area and further declaring June
6 27, 2001 as Carl Anthony Day in the City and County of San Francisco.

8 WHEREAS, Carl Anthony is the founder and Executive Director of
9 the Urban Habitat Program (UHP), a non-profit environmental justice
10 organization which advocates for sustainable urban development,
11 creation of healthy urban environments, preservation of open space and
12 livable communities as well as the promotion of social justice and
13 multi-cultural urban leadership; and

14 WHEREAS, From 1991 to 1997, Carl Anthony was the President of
15 Earth Island Institute, a non-profit organization dedicated to the
16 conservation, preservation and restoration of the Earth's natural
17 environment; and

18 WHEREAS, From 1993 through 1995, Carl Anthony was Chair and
19 Principal Administrative Officer of the East Bay Conservation and
20 Reinvestment Commission, created by former Congressman Ron Dellums to
21 guide the federal policy in base conversion projects as well as to
22 establish policy guidelines for the conversion and reuse of five
23 military installations in Alameda County; and

1 WHERAS, Trained as an architect and town planner at Columbia
2 University, Carl Anthony, began his professional career in the late
3 1960's in Harlem; and

4 WHEREAS, In 1970, through a William Kinne Fellowship, Carl
5 Anthony traveled to West Africa to document life in various
6 traditional villages which led him to deepen his respect for the
7 natural environment, for natural processes such as the cycles of the
8 seasons, climate and local natural resources as well as respect for
9 local cultures; and

10 WHEREAS, Carl was further impressed by the way indigenous
11 cultures shaped their environments with limited natural resources to
12 meet basic needs as well as reflect human values; and

13 WHEREAS, In 1971, he was appointed Assistant Professor of
14 Architecture at the University of California, Berkeley, where he
15 conducted undergraduate and graduate studios, lectures, and seminars
16 in energy conservation, site planning, social factors such as design
17 determinants of architectural form, supervision of masters and
18 doctoral work; and

19 WHEREAS, Carl Anthony has also distinguished himself by serving
20 as a member in various organizations: adjunct member at the Columbia
21 University of Graduate School of Architecture and Planning, member of
22 the Visitors Committee and Environmental and Natural Resources
23 Committee of the Stanford University Law School, faculty and advisory
24 member of the College of Natural Resources at the University of

1 California, Berkeley, a Fellowship recipient at the Institute of
2 Politics at Harvard University; and

3 WHEREAS, In 1979, Carl Anthony established his own urban design
4 and architectural practice in which he and his associates integrated
5 principles for the resolution of urban conflicts in their planning
6 projects; and

7 WHEREAS, Working with 10 neighborhoods in North Omaha, he
8 developed a multi-year master plan for a three square mile area of the
9 City of Omaha, including tree planting, repair of sidewalks,
10 rehabilitation of 600 homes and the creation of a community market;
11 and

12 WHEREAS, As a consultant to Berkeley's Redevelopment Agency, he
13 resolved a 15-year conflict over development of six acres of vacant
14 City-owned land in Oceanview neighborhood, the oldest section of the
15 community, and initiated a successful plan for affordable housing,
16 historic preservation, and community economic development; and now,
17 therefore, be it

18 RESOLVED that the City and County of San Francisco does hereby
19 commend Mr. Carl Anthony for his exemplary accomplishments and
20 invaluable contributions to the citizens of the nine counties of the
21 San Francisco Bay Area, especially for his tireless efforts towards
22 the preservation, conservation and restoration of the natural
23 environment, the promotion and advocacy of social justice and
24 sustainable urban development, and the creation of livable communities
25

1 which reflect the deepest human values of peace, equity, community,
2 and partnership with the natural environment; now be it

3 FURTHER RESOLVED, That the Board of Supervisors hereby
4 declare June 27, 2001 as Carl Anthony Day in the City and County of
5 San Francisco.
