5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
6 and the San Francisco Traffic Code, the following regulations governing the parking of  
7 vehicles are hereby enacted or rescinded as designated below:

8 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

9 2971 21st Street, south side, between the driveways for #2965 - and #2971-  
10 21st Street (establishes three motorcycle parking spaces); and,

11 Octavia Boulevard, east side, from Linden Street to 14 feet northerly  
12 (accommodating 4 motorcycle parking spaces)

13 **TOW-AWAY, NO STOPPING, 3 PM TO 6 PM, MONDAY THROUGH FRIDAY -**  
14 **RESCIND**

15 **TOW-AWAY, NO STOPPING, 3 PM TO 7 PM, MONDAY THROUGH FRIDAY -**  
16 **ESTABLISH**

17 Pine Street, south side, from Polk Street to Larkin Street.

18 **TOW-AWAY, NO STOPPING, 7 AM TO 7 PM EVERYDAY- RESCIND**  
19 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

20 Clay Street, south side, from Stockton Street to 84 feet westerly.

21 **TOW-AWAY NO STOPPING, 6 AM TO 6 PM EVERYDAY - RESCIND**  
22 **TOW-AWAY NO STOPPING, 7 AM TO 7 PM, EVERYDAY - ESTABLISH**

23 Sacramento Street, north side, between Powell and Mason Streets

24 **TOW-AWAY NO STOPPING, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY -**

Clay Street, north side, between Davis Street and 18 feet easterly

**RESIDENTIAL PERMIT PARKING AREA "X" (2-HOUR TIME LIMIT, 8 AM TO 6 PM, MONDAY THROUGH FRIDAY) - ESTABLISH**

Pennsylvania Avenue, west side, from 20th Street to 127 feet north of 22nd Street (500 and 600 blocks up and including address #672) (legislating existing conditions)

Categorically exempt from Environmental Review Class 1(c)(9) changes in the traffic and parking regulations where such changes do not establish a higher speed limit or result in more than a negligible increase in the use of the street.


