15 Section 1. The Board of Supervisors hereby adopts and implements the decision and
16 award of the Arbitration Board under Charter Section A8.590-5, establishing the 2018-2021
17 Memorandum of Understanding ("MOU") between the City and County of San Francisco and
18 the San Francisco Police Officers' Association, to be effective July 1, 2018 through
19 June 30, 2021.

20 The Arbitration Board decision and award and the MOU so implemented are on file
21 with the Clerk of the Board of Supervisors in Board File No. 180504.

22 Section 2. The Board of Supervisors hereby authorizes the Department of Human
23 Resources to make non-substantive ministerial or administrative corrections to the MOU.

1 Section 3. Effective Date. This ordinance shall become effective upon enactment.
2 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance
3 unsigned or does not sign the ordinance within ten days of receiving it, or the Board of
4 Supervisors overrides the Mayor's veto of the ordinance.




