10 and Highways Code, Sections 27120, et seq., for the terms specified:

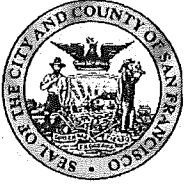
11 Sabrina Hernandez, seat 1, succeeding herself, term expired, must represent the
