3 **Resolution calling upon the United States Congress to exercise its constitutional**
4 **authority to revoke the United States' commitment of military forces in Iraq and to**
5 **secure the immediate, safe and orderly withdrawal of all our troops from Iraq.**

7 WHEREAS, It has long been exposed that President Bush's War in Iraq is an ill-
8 conceived and disastrously executed quagmire which has cost our country the lives of 3,100
9 brave soldiers, another 23,000 soldiers wounded, and close to \$400 billion; and

10 WHEREAS, The Bush administration that so recklessly led the nation into war four
11 years ago now offers no realistic hope of victory nor any plan for withdrawal; and,

12 WHEREAS, A late February, 2007 Washington Post- ABC News Poll showed that 53%
13 of Americans want our military forces out of Iraq; and,

14 WHEREAS, The American people are now looking to the Congress to bring President
15 Bush's War in Iraq to an end and to prevent further military calamity in other parts of the
16 Middle East and elsewhere; and,

17 WHEREAS, During the week of March 12, 2007, the House of Appropriations
18 Committee will be voting on the withdrawal of all funding for Iraq; now, therefore, be it

19 RESOLVED, That San Francisco Board of Supervisors hereby commends the
20 bipartisan congressional leadership for beginning to call President Bush and his
21 administration to account for their total failure in Iraq; and, be it

22 FURTHER RESOLVED, That the Board of Supervisors calls upon the United States
23 Congress to revoke the authority it had granted for commitment of U.S. military forces in Iraq,
24 to discontinue funding for ongoing military operations there and to fully fund the safe and
25 orderly withdrawal of all troops from Iraq.
