13 WHEREAS, The Department of Human Services desires to hire consultants to develop  
14 and implement this program; and

15 WHEREAS, The State of California, Governor's Office of Emergency Services will  
16 grant \$700,000 for this program; and,

17 WHEREAS, The Department proposes to maximize use of available grant funds on  
18 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

19 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
20 the grant budget; and be it


