1 [Funding Reallocation - Our City, Our Home Homelessness Gross Receipts Tax - Services to  
2 Prevent Homelessness - \$60,000,000]

3 **Ordinance reallocating approximately \$60,000,000 in unencumbered revenues from the**  
4 **Our City, Our Home Fund to allow the City to use revenues from the Homelessness**  
5 **Gross Receipts Tax for certain types of services to prevent homelessness; and finding**  
6 **that the reallocation is necessary to achieve purposes of the Our City, Our Home Fund**  
7 **pursuant to Business and Tax Regulations Code, Section 2811.**

15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. Background and Findings.

17 (a) In November 2018, the voters approved Proposition C and imposed a  
18 Homelessness Gross Receipts Tax to fund programs to prevent and address homelessness.  
19 As stated in the measure, “San Francisco is experiencing a housing crisis of historic  
20 proportions that has led to a major humanitarian and public health crisis in large-scale  
21 homelessness for which the City has insufficient resources to address.”

22 (b) Recognizing the scope of the crisis, the voters identified a range of purposes for  
23 the tax, the proceeds of which the City deposits in the Our City, Our Home (“OCOH”) Fund.  
24 Among other things, the tax is intended to help the City house the homeless; expand the  
25 number of shelter beds; eliminate waiting periods for shelter; decrease the visible presence of  
homeless people and tent encampments on City streets; move unhoused people into stable  
housing; fund legal assistance, rent subsidies, mental health services, and substance abuse

1 services to keep people housed; reduce overall costs for the City; and fund certain specified  
2 programs. The purposes of November 2018 Proposition C are codified at Business and Tax  
3 Regulations Code Section 2802.

4 (c) To achieve these purposes, Business and Tax Regulations Code Section 2810  
5 identifies four eligible programs that the City may spend OCOH funds on – Permanent  
6 Housing, Homeless Shelters, Homelessness Prevention, and Mental Health Treatment for  
7 Homeless Individuals – and identifies a maximum or minimum percentage of the total OCOH  
8 Fund balance that each eligible program receives. Section 2810 further states that OCOH  
9 funds shall be appropriated subject to the budgetary and fiscal provisions of the Charter, and  
10 that any amounts remaining in the OCOH Fund at the end of a fiscal year shall be held in the  
11 OCOH Fund to be added to amounts available for appropriation on eligible programs in any  
12 future year. In Section 2811, the voters also authorized the Board of Supervisors to amend  
13 the measure, by ordinance, by a two-thirds vote and only to further the findings and intent  
14 summarized above in subsection (b).

15 (d) The City is fully funding all of the programs recommended by the OCOH  
16 Oversight Committee, which makes recommendations for the use of the Fund. And yet, there  
17 is a significant unencumbered balance in the Fund, in large part because the City has  
18 obtained approximately \$94 million in state and federal funds for permanent housing for  
19 families and transitional age youth. The original percentage allocations in Section 2810 are  
20 based on the total Fund balance and did not anticipate these additional revenues, and as  
21 Fund revenues sit unspent, thousands are still on the streets without adequate shelter. In  
22 April 2023, the City published a new citywide Strategic Plan that concludes it is necessary to  
23 urgently fund shelter, prevention, and housing resources to significantly reduce homelessness  
24 in the next five years. The Board of Supervisors finds that to achieve the purposes of  
25 November 2018 Proposition C, the City must meet the crisis where it is currently most acute,

1 and hereby approves a reallocation of certain unencumbered and future revenues so it can  
2 spend these revenues during the next two fiscal years on shelter, homelessness prevention,  
3 limited-time rental assistance, and other forms of permanent housing, as generally set forth in  
4 the Strategic Plan.

5 (e) In approving this one-time reallocation of funds for the next two fiscal years, the  
6 Board of Supervisors does not intend to otherwise adjust the percentage allocations for  
7 OCOH expenditures in future fiscal years. The reallocation is intended to supplement and  
8 enhance the effectiveness of the programs already funded on recommendation of the OCOH  
9 Oversight Committee.

10  
11 Section 3. Under the authority in Business and Tax Regulations Code Section 2811,  
12 for fiscal year 2023-2024:

13 (a) Expenditures under Section 2810(b)(3)(A) on permanent housing, not limited to  
14 supporting homeless youth aged 18 through 29 and homeless families with children under  
15 age 18 at the time of entry into housing, may be \$3,418,500 more than the percentages  
16 specified in Sections 2810(b)(3)(A) and 2810(b)(3)(A)(i);

17 (b) Expenditures under Section 2810(b)(3)(B) on homeless shelters and hygiene  
18 programs may be \$8,140,000 more than the percentage specified in Section 2810(b)(3)(B);

19 (c) Expenditures under Section 2810(b)(3)(C) on homelessness prevention may be  
20 \$9,082,000 more than the percentage specified in Section 2810(b)(3)(C);

21 (d) Expenditures under Section 2810(b)(3)(A) on permanent housing that supports  
22 homeless youth aged 18 through 29 may be \$11,798,000 below the percentage specified in  
23 Section 2810(b)(3)(A); and

1 (e) Expenditures under Section 2810(b)(3)(A) on permanent housing that supports  
2 homeless families with children under age 18 at the time of entry into housing may be  
3 \$8,842,500 below the percentage specified in Section 2810(b)(3)(A).  
4

5 Section 4. Under the authority in Business and Tax Regulations Code Section 2811,  
6 for fiscal year 2024-2025:

7 (a) Expenditures under Section 2810(b)(3)(A) on permanent housing, not limited to  
8 supporting homeless youth aged 18 through 29 and homeless families with children under  
9 age 18 at the time of entry into housing, may be \$14,831,500 more than the percentages  
10 specified in Sections 2810(b)(3)(A) and 2810(b)(3)(A)(i);

11 (b) Expenditures under Section 2810(b)(3)(B) on homeless shelters and hygiene  
12 programs may be \$13,440,000 more than the percentage specified in Section 2810(b)(3)(B);

13 (c) Expenditures under Section 2810(b)(3)(C) on homelessness prevention may be  
14 \$11,088,000 more than the percentage specified in Section 2810(b)(3)(C);

15 (d) Expenditures under Section 2810(B)(3)(A) on permanent housing that supports  
16 homeless youth aged 18 through 29 may be \$20,157,500 below the percentage specified in  
17 Section 2810(b)(3)(A); and

18 (e) Expenditures under Section 2810(b)(3)(A) on permanent housing that supports  
19 homeless families with children under age 18 at the time of entry into housing may be  
20 \$19,202,000 below the percentage specified in Section 2810(b)(3)(A).  
21

22 Section 5. Effective Date. This ordinance shall become effective 30 days after  
23 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
24 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
25 of Supervisors overrides the Mayor's veto of the ordinance.

1  
2 Section 6. Undertaking for the General Welfare. In enacting and implementing this  
3 ordinance, the City is assuming an undertaking only to promote the general welfare. It is not  
4 assuming, nor is it imposing on its officers and employees, an obligation for breach of which it  
5 is liable in money damages to any person who claims that such breach proximately caused  
6 injury.  
7

8 Section 7. Severability. If any section, subsection, sentence, clause, phrase, or word of  
9 this ordinance, or any application thereof to any person or circumstance, is held to be invalid  
10 or unconstitutional by a decision of a court of competent jurisdiction, such decision shall not  
11 affect the validity of the remaining portions or applications of the ordinance. The Board of  
12 Supervisors hereby declares that it would have passed this ordinance and each and every  
13 section, subsection, sentence, clause, phrase, and word not declared invalid or  
14 unconstitutional without regard to whether any other portion of this ordinance or application  
15 thereof would be subsequently declared invalid or unconstitutional.  
16

17 Section 8. No Conflict with Federal or State Law. Nothing in this ordinance shall be  
18 interpreted or applied so as to create any requirement, power, or duty in conflict with any  
19 federal or state law.

## LEGISLATIVE DIGEST

[Funding Reallocation - Our City, Our Home Homelessness Gross Receipts Tax - Services to Prevent Homelessness - \$60,000,000]

**Ordinance reallocating approximately \$60,000,000 in unencumbered revenues from the Our City, Our Home Fund to allow the City to use revenues from the Homelessness Gross Receipts Tax for certain types of services to prevent homelessness; and finding that the reallocation is necessary to achieve purposes of the Our City, Our Home Fund pursuant to Business and Tax Regulations Code, Section 2811.**

### Existing Law

November 2018's Proposition C, codified at Article 28 of the Business and Tax Regulations Code, imposed a Homelessness Gross Receipts Tax to help fund programs to prevent and address homelessness. The City deposits the proceeds of this tax in the Our City, Our Home ("OCOH") Fund. The City may use the OCOH Fund on four "eligible programs," as follows:

- At least 50% for permanent housing, of which up to 12% may fund short-term rental subsidies, at least 20% must support homeless youth aged 18 through 29, and at least 25% must support homeless families with children under 18.
- Up to 10% for shelters and hygiene programs.
- Up to 15% for homelessness prevention.
- At least 25% for mental health for homeless individuals.

The Board of Supervisors may amend Article 28 by ordinance, by a two-thirds vote and only to further the overall findings and intent of Proposition C.

### Amendments to Current Law

The ordinance would authorize the City, during Fiscal Years 2023-24 and 2024-25 only, to increase the OCOH funding for shelter, homelessness prevention, limited-time rental assistance, and permanent housing not specifically limited to youth and families, despite the percentage caps that would otherwise apply to certain of those categories. The City would pay for this by reallocating OCOH funds that would help pay for permanent housing that supports youth aged 18 through 29, and families with children under 18. In Fiscal Year 2023-24, the ordinance would reallocate approximately \$21 million. In Fiscal Year 2024-25, the ordinance would reallocate approximately \$39 million. The total OCOH funds allocated for mental health services during these two fiscal years would still be at least 25%. After 2024-25, the percentages for the eligible programs would revert to those specified in Article 28.

Background Information

The City is able to reallocate OCOH funding that would otherwise fund permanent housing for homeless youth and families in large part because it has obtained approximately \$94 million from other sources (state and federal funds) for those programs. Given the current state of the homelessness crisis, it is necessary to reallocate funding to where it is most needed.

## MANDATE STATEMENT

Charter Section 2.105 requires that legislative acts in San Francisco be by ordinance, subject to approval by a majority of the Board of Supervisors.

Business and Tax Regulations Code Section 2811 states that amendments to the Homeless Gross Receipts Tax are subject to Board of Supervisors approval by a two-thirds vote. Such amendments may only be to further the purpose of the tax.

## BACKGROUND

The Homelessness Gross Receipts Tax was authorized by voters in November 2018 with the passage of Proposition C and became effective in January 2019. The tax added between 0.175% to 0.69%, depending on the businesses type, to the gross receipts tax on businesses earning over \$50 million in a given year.

Under current law, expenditures of Homelessness Gross Receipts Tax revenues must be spent in the following manner:

- At least of 50 percent on permanent housing
  - Of which, at least 20 percent must be spent on transitional aged youth (TAY), defined as underage 30
  - Of which, at least 25 percent must be spent on family housing
  - Of which, the remaining portion must be spent on general housing, serving all populations
  - Of which, no more than 12 percent can be spent on short-term (less than five-year) rental subsidies
- Up to 10 percent on shelter and hygiene programs
- Up to 15 percent on prevention programs
- At least 25 percent on mental health services

## DETAILS OF PROPOSED LEGISLATION

The proposed ordinance would modify the Homelessness Gross Receipt Tax funding allocation requirements by \$20.6 million FY 2023-24 and \$39.4 million FY 2024-25. The requirements for funding housing for TAY and families would be decreased in in FY2023-24 and re-allocated to adult housing, shelter, and prevention. The change in funding allocation percentages is shown below in Exhibit 1.

**EXECUTIVE SUMMARY**

- Up to 10 percent on shelter and hygiene programs
- Up to 15 percent on prevention programs
- At least 25 percent on mental health services

## DETAILS OF PROPOSED LEGISLATION

The proposed ordinance would modify the Homelessness Gross Receipt Tax funding allocation requirements by \$20.6 million FY 2023-24 and \$39.4 million FY 2024-25. The requirements for funding housing for TAY and families would be decreased in FY2023-24 and re-allocated to adult housing, shelter, and prevention. The change in funding allocation percentages is shown below in Exhibit 1.

In FY 2023-24, the proposed \$20.6 million decrease to TAY and families permanent housing category would be used to fund the increase in general housing, shelter for adults and families, and prevention programming for all populations.

In FY 2024-25, the ordinance would enable the reallocation of prior year HSH project funding of \$39.4 million to be appropriated for general housing, shelter for families and adults, and prevention for all populations.

**POLICY CONSIDERATION****Existing Funding Resources**

As of June 1, 2023, the City had \$858 million in Homelessness Gross Receipt Tax spending budgeted. Actual revenues have been \$21 million less than budgeted this year. As of June 12, 2023 in FY 2022-23, \$268 million had been spent and \$113 million was encumbered, leaving a remaining unspent balance of \$478 million, which is assigned to various projects. The proposed budget re-appropriates \$75.9 million of unspent projects, including \$39.4 million in FY 2024-25 proposed spending that is subject of this ordinance.

**Oversight Committee Recommendation**

At its June 9, 2023 meeting, the Our City, Our Home Oversight Committee meeting approved a motion to request the Mayor's Office not reduce family and youth housing funding and look for other sources of funding to maintain the levels of funding for those programs as required by the Homelessness Gross Receipts Tax.

**RECOMMENDATION**

Approval of the proposed ordinance is a policy matter for the Board of Supervisors.



My name is Calder Lorenz, I live and work in the Mission District, and I am the Director of Operations for The Gubbio Project. I am writing to voice our strong opposition to reallocating approximately \$60M from the Prop C Housing fund that was allocated for transitional aged youth and families.

We urge you to vote NO on moving this funding over to primarily adult interventions such as housing, prevention and shelter, items the Mayor should have funded within the city's \$14 billion budget.

As members of the OCOH coalition, we fought hard to get Prop C passed. Voters trusted the framework of this ground breaking proposition and approved Prop C deliberately to set aside funding for families and youth because they are hidden populations that have been historically ignored.

The measure was also deliberately crafted to have a community oversight body to ensure the vision of Prop C was realized. They spend hours pouring over budgets, getting input from hundreds of unhouse people and front-line service providers to ensure just that. These last-minute plans did not go through OCOH (Prop C) Oversight Committee.

Since there has been a lot of closing / exodus of businesses, onsite workers and general NORMAL life in the Downtown / Financial District area. The unhoused, self-medicators and their suppliers have been frequenting the Central waterfront on the Embarcadero causing problems to the tax paying businesses on these trying times.

My wife and I avoid going into Downtown (4<sup>th</sup> and Market), SOMA and Civic Center area at all costs. She is a recent immigrant to this Beautiful City. Coming from the Philippines (a 3<sup>rd</sup> world country) she fears more for her life here in San Francisco than back in Manila; walking around / running errands in Downtown. She and I are very disappointed with what this City has become. She was excited to live and work in San Francisco for a better and safer life with how progressive, technologically advance and secure she thought the City was.

To elaborate more on our accounts with the unhoused population: We have had two separate incidents where our managerial staff have been battered and been physically assaulted by the unhoused asking for money to our outdoor patio guests. On both accounts the police have been called and a police report has been filed. These assaults happened within one week from each other THIS JUNE. We are fearing for our safety and the safety of our guests as seemingly we have no support or rights to defend our business, our patrons and staff. These recent attacks on my colleagues have put a strain on our Mental Health as managers protecting our guests, staff and business. We are honestly looking for alternative lines of either work or location at a safer environment if thing do not change.

We are located on the Embarcadero and there has been an uptick on tents on the Embarcadero, Davis and surrounding streets.
