

1 [Grant to provide direct access to housing for chronic alcoholics.]

3 **Resolution authorizing the San Francisco Department of Public Health (SFDPH), to**  
4 **accept retroactively and expend a new grant in the amount of \$982,033 from the US**  
5 **Department of Housing and Urban Development (HUD) for direct access to housing for**  
6 **chronic alcoholics, to enter into an agreement for the use of these funds, and to add**  
7 **one (1.0) new position funded through this agreement; for the period of April 1, 2006, to**  
8 **March 31, 2008.**

10 WHEREAS, SFDPH has applied for and been awarded a grant in the amount of  
11 \$982,033 from HUD for direct access to housing for chronic alcoholics; and,

12 WHEREAS, As a condition of receiving the grant funds, HUD requires the City to enter  
13 into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of  
14 Supervisors in File No. 060498; which is hereby declared to be a part of this  
15 resolution as if set forth fully herein; and,

16 WHEREAS, Resolutions authorizing the acceptance and expenditure of grant funds  
17 may be placed automatically on consent agendas in committee, as they are usually  
18 considered to be routine items, and this resolution authorizes the acceptance and expenditure  
19 of grant funding; and,

20 WHEREAS, One (1.0) new position will be added through this grant; and,

21 WHEREAS, The grant budget includes provision for indirect costs of \$40,644; now,  
22 therefore, be it

23 RESOLVED, That SFDPH is hereby authorized to accept retroactively and expend a  
24 grant in the amount of \$982,033 from HUD; and, be it



FURTHER RESOLVED, That the Controller is directed to designate the positions funded under this agreement as "G" or grant-funded positions which would terminate when the agreement expires.




