2 PROCLAIMING AUGUST 14, 1999, "CANNABIS HELPING TO ALLEVIATE MEDICAL  
3 PROBLEMS (C.H.A.M.P.) DAY" IN SAN FRANCISCO

5 WHEREAS, Cannabis Helping Alleviate Medical Problems (C.H.A.M.P.) was founded  
6 in 1996, shortly after passage of Proposition 215; and

7 WHEREAS, C.H.A.M.P. has been providing the Castro community with safe access to  
8 medical cannabis since that time ; and,

9 WHEREAS, C.H.A.M.P. had to close its doors under threat of prosecution from the  
10 federal government, as well as because of financial woes; but, in February, 1998, reopened  
11 again at 195 Church St.; and,

12 WHEREAS, C.H.A.M.P. sponsors wellness groups that lend emotional/psychological  
13 support, weekly dinners that feed the hungry, and classes that teach people how to grow their  
14 own medicine; and

15 WHEREAS, C.H.A.M.P. set up a growing operation in Sonoma County, which has  
16 been prosecuted by Sonoma County law enforcement without regard for protocol or concern  
17 for the many sick people who will have to endure pain and suffering without the medicinal  
18 benefit of this crop; now, therefore, be it

19 RESOLVED, That C.H.A.M.P. is to be commended for its faithful commitment to  
20 helping persons suffering from the ravages of HIV/AIDS, cancer, and other devastating and  
21 life-threatening disease by fighting to provide safe access to medical cannabis; and, be it

22 FURTHER RESOLVED, That August 14, 1999, is proclaimed "Cannabis Helping To  
23 Alleviate Medical Problems (C.H.A.M.P) Day" in San Francisco.




