**Re: Technical adjustments to the Mayor's Proposed Budget #1**

Supervisor Farrell:

Per Charter Section 9.101, I am submitting the attached technical adjustments to the Mayor's Proposed Budget for FY 2014-15 and FY 2015-16. Significant changes include:

- Correctly balancing workorders in a number of departments including the City Administrator's Office, the War Memorial, the Department of the Environment, the Office of Economic and Workforce Development, the Police Department, the Board of Supervisors, and the Public Utilities Commission;
- Moving the funds for the financial systems replacement project to allow for better tracking of the project;
- Moving funds within project codes, grant codes, and/or index codes at the Sheriff's Department, the Port Commission, the Department of Technology, the Human Services Agency, and the Recreation and Park Department to more accurately reflect the intended use of the funds;
- Correcting grant funds at the Office of Economic and Workforce Development and the City Administrator's Office that were inadvertently omitted from the Mayor's budget;
- Adjusting equipment purchases at the Department of Public Health and the Recreation and Park Department between fiscal years and equipment type to more accurately reflect the department's need; and
- Adjustments to salary and fringe benefits for the Controller's Office, the Department of Public Health, the Department of Public Works, the Human Services Agency, the Police Department, the Sheriff's Department and the Department of the Environment to accurately reflect departmental staffing needs and work order requests from other departments.

Note that these technical adjustments result in General Fund savings in FY 2014-15 of \$12,704 and a General Fund savings in FY 2015-16 of \$353,340. The attached tables detail these changes. The figures may change slightly once they are entered into the budget system.

- Moving funds within project codes, grant codes, and/or index codes at the Public Utilities Commission, the Department of Technology, the Treasurer-Tax Collector, the Recreation and Park Department, the Mayor's Office of Housing and Community Development, the Department of Public Health, the Human Rights Commission, the Department of Children Youth and their Families, and the Art Commission; and

**Re: Technical adjustments to the Mayor's Proposed Budget #4**

Supervisor Farrell:

Per Charter Section 9.101, I am transmitting the technical detail codifying the technical adjustments made on June 25, 2014 to the Mayor's Proposed Budget for FY 2014-15 and FY 2015-16. These adjustments include:

1. Appropriating \$1.58 of prior year fund balance which was identified by the Board of Supervisor's Budget and Legislative Analyst.
2. Addressing changes resulting from the State of California's budget including:
  - Appropriating one-time repayments from the State in FY 2014-15 of approximately \$3.35 million of mandate claims owed by the State to local governments and early repayment \$3.98 million of the Highway Users Tax Account (HUTA);
  - Partially offset by cost-of-living adjustments to the County Adult Assistance Program triggered by the State's CalWORKS grant increases; and
  - Appropriating revenue and offsetting expenditures from the state for foster care, homelessness, and children services at the Human Services Agency.
3. Reductions in General Fund revenue of \$1.35 million and accompanying reductions to other baselines due to a policy change to increase the Children's Fund baseline in FY 15-16.
4. Balancing fund balance use over the two years.

The changes described above, and the balance of the Mayor's Technical Adjustment Reserve, total \$12.21 million in additional General Fund resources which are now available for appropriation by the Board.
