14 WHEREAS, Rule 4.38 of the Rules of Order of the Board of Supervisors requires that  
15 all proposed amendments to the Rules of Order shall be referred to the Rules Committee for  
16 public hearing and recommendation; and,

17 WHEREAS, Rule 4.37 of the Rules of Order allows Rule 4.38 to be suspended by the  
18 affirmative vote of eight members of the Board, unless there are less than eight Board  
19 members present, in which case the unanimous consent of the members present, but not less  
20 than six members, shall be required; and,

21 WHEREAS, The members of the Board of Supervisors wish to suspend the operation  
22 of Rule 4.38 with regard to the consideration of the proposed amendment to Rule 5.1, now,  
23 therefore, be it

24 **MOVED**, That the Board of Supervisors of the City and County of San Francisco, as  
25 allowed by Rule 4.37 of its Rules of Order, hereby suspends the operation of Rule 4.38 of the

1 Board's Rules of Order with regard to the Board's consideration of the proposed amendment  
2 to Rule 5.1; and, be it

3 FURTHER MOVED, That the Board of Supervisors of the City and County of San  
4 Francisco shall hereby convene as a committee of the whole on March 1, 2005, to accept  
5 public testimony concerning the possible amendment to Board Rule 5.1.
