3 **Resolution determining that the transfer of a Type-21 off-sale general beer, wine,**
4 **and distilled spirits license; the transfer of a Type-42 on-sale beer and wine public**
5 **premises license; and the transfer of a Type-86 educational tasting license to**
6 **California Wine and Spirits LLC, doing business as Total Wine & More located**
7 **at 1750 Harrison Street (District 9), will serve the public convenience or necessity**
8 **of the City and County of San Francisco, in accordance with California Business**
9 **and Professions Code, Section 23958.4; and requesting that the California**
10 **Department of Alcoholic Beverage Control impose a condition on the issuance of**
11 **the license.**

13 WHEREAS, California Wine and Spirits LLC, is seeking the transfer of a Type-21
14 off-sale general beer, wine, and distilled spirits license; the transfer of a Type-42 on-sale
15 beer and wine public premises license; and the transfer of a Type-86 educational tasting
16 liquor license to do business as Total Wine & More located at 1750 Harrison Street
17 (District 9); and

18 WHEREAS, The Planning Department has verified that the area is properly
19 zoned and recommends approval; and

20 WHEREAS, The Police Department has filed two protests and zero letters of
21 support with the Department of Alcoholic Beverage Control under California Business
22 and Professions Code, Section 24013, and recommends that the Department of
23 Alcoholic Beverage Control issue the liquor license with a condition; and

24 WHEREAS, The conditions recommended by the Police Department are the
25 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort

1 to prevent the loitering of persons on any property adjacent to the licensed premises as
2 depicted on the ABC-253.; now, therefore, be it

3 RESOLVED, That in accordance with California Business and Professions Code,
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
5 hereby determines that the transfer of a Type-21 off-sale general beer, wine, and
6 distilled spirits license; the transfer of a Type-42 on-sale beer and wine public premises
7 license; and the transfer of a Type-86 educational tasting license to California Wine and
8 Spirits LLC, doing business as Total Wine & More located at 1750 Harrison Street, will
9 serve the public convenience or necessity of the City and County of San Francisco; and,
10 be it

11 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
12 San Francisco hereby endorses and adopts the recommendations of the Police
13 Department listed above and recommends that the Department of Alcoholic Beverage
14 Control issue the license with a condition.
