2 **Resolution urging the Director of the Department of Human Services to**
3 **permanently locate the San Francisco Day Laborer Program at the 3120**
4 **Mission Street site and to negotiate with the current owners of the**
5 **Department's intentions.**

6 WHEREAS, For the past eleven years the San Francisco Day Labor
7 Program has provided comprehensive services to thousands of San Francisco's
8 day laborers and facilitated the education, empowerment and organizing of day
9 laborers; and

10 WHEREAS, The Day Laborer Program has operated for the past eleven
11 years from two portable trailers and under deplorable and difficult working
12 conditions; and

13 WHEREAS, The Program was strategically located on 17th and Hampshire
14 Street near Cesar Chavez Boulevard where the majority of day laborers
15 congregate; and

16 WHEREAS, The location at 17th Street was to have been temporary until a
17 permanent location on Cesar Chavez could be located; and

18 WHEREAS, The Program staff has diligently searched for appropriate
19 location and has faced numerous obstacles, primarily from a minority of
20 community residents; and

21 WHEREAS, A substantial number of neighborhood residents and
22 merchants have voiced their support of the program;

23 WHEREAS, Currently the Program is negotiating with the Department of
24 Human Services (DHS) to sub-lease space in the building formerly occupied by
25 the Employment Development Department (EDD) located at 3120 Mission Street;
and

1 WHEREAS, The building located at 3120 Mission Street is privately
2 owned by KLWLLC and DHS will be primary tenant; and

3 WHEREAS, The rear part of the 3120 Mission Street site appears to be an
4 appropriate site for the permanent location of the San Francisco Day Laborer
5 Program; and

6 WHEREAS, It is in the interest of the Board of Supervisors and citizens of
7 San Francisco to do facilitate the creation of programs that can ameliorate the
8 problem of unemployment and address the social needs of a population that is
9 marginalized and underserved; be it therefore

10 RESOLVED, That the Board of Supervisors of the City and County of San
11 Francisco strongly urges the Director of the Department of Human to
12 permanently locate the San Francisco Day Laborer Program at the 3120 Mission
13 Street site and to negotiate with the current owners of the Department's
14 intentions; and be it

15 FURTHER RESOLVED, That the Board of Supervisors request that
16 copies of this resolution be transmitted to the Director of the Department of
17 Human Services as well as to the current owners of the 3120 Mission Street site.
