1	[Urging Governor Newsom to Commute All Death Sentences in California]
2	
3	Resolution urging Governor Gavin Newsom to use his executive powers to commute
4	the death sentences for all individuals currently sentenced to death in California.
5	
6	WHEREAS, There are currently 565 individuals sentenced to death in California.
7	California has the largest death row in the nation and one of the largest death rows in the
8	world; and
9	WHEREAS, San Francisco County has no individuals sentenced to death and the
10	voters of San Francisco have twice voted to repeal the death penalty in 2012 and 2016; and
11	WHEREAS, The death penalty reflects a legacy of racial discrimination; Sixty-nine
12	percent of the people under a sentence of death in California are people of color, and one-
13	third are Black; and
14	WHEREAS, Death sentences are more likely to be imposed in California when the
15	victims are white than when they are Black or Latino, while the majority of homicides with
16	Black or Latino victims go unsolved; and
17	WHEREAS, The California Task Force to Study and Develop Reparation
18	recommended abolishing the death penalty as a step to addressing the legacy of slavery in
19	California; and
20	WHEREAS, Almost half of the people on California's death row are there for crimes
21	they committed as youth under the age of 26, and approximately one in six were under 21
22	years old; and
23	WHEREAS, Recognizing that young people's brains are not fully developed until their
24	mid 20s, California has enacted several reforms to address the diminished culpability of
25	

1	youthful offenders and individuals on death row and those serving life without parole are
2	excluded from these policies; and
3	WHEREAS, More than one third of people on death row in California have been
4	diagnosed with a serious mental illness and dozens have been diagnosed with intellectual
5	disabilities; and
6	WHEREAS, A study by the National Academy of Sciences estimates that at least four
7	percent of people sentenced to death in the U.S. are innocent and California has already
8	exonerated eight men from death row due to wrongful conviction, all of them people of color;
9	and
10	WHEREAS, California's death penalty system has cost taxpayers \$5 billion since 1977,
11	Meanwhile funding for vital victims services are being reduced in California due to Congress's
12	drastic cuts to funding for the Victims of Crime Act; and
13	WHEREAS, Two-thirds of the individuals sentenced to death in California have been
14	there for more than 20 years, and dozens of individuals have been on death row for more than
15	40 years with literally decades of delays caused by California's inability to provide lawyers to
16	handle capital appeals; and
17	WHEREAS, The California Democratic Party Platform supports the full repeal of the
18	death penalty and the Party has twice endorsed initiatives to repeal the death penalty; and
19	WHEREAS, Under the California Constitution, the Governor of California has the power
20	to commute death sentences, with the review and concurrence of a majority of the California
21	Supreme Court justices in certain cases; and
22	WHEREAS, The San Francisco Opera will present from September 14 to 28, 2025,
23	Dead Man Walking, an opera commissioned by San Francisco Opera 25 years ago about
24	Sister Helen Prejean's spiritual journey accompanying a man on death row that informed her
25	fight to end the death penalty in the United States; now, therefore, be it

1	RESOLVED, That the Board of Supervisors for the City and County of San Francisco
2	urges Governor Newsom to act now to commute all death sentences; and, be it
3	FURTHER RESOLVED, That the Clerk of the Board is hereby directed to transmit a
4	copy of this Resolution to Governor Gavin Newsom.

Dear SF Supervisors and staff,

I am a long-time San Francisco resident and an attorney, very recently retired from 36 years of death penalty defense work. I write to urge you all to support Supervisor Fielder's resolution calling on Governor Newsom to commute all death sentences.

The death penalty system is broken in myriad ways. One example of that is that literally hundreds of death-sentenced people in this state have been waiting 10, 15, or even 20 years for appointment of habeas corpus counsel to investigate and present any arguable claims on state habeas corpus, a proceeding to which they are entitled under California law. There is no realistic prospect of such counsel being appointed in the foreseeable future because there is no funding for such representation, which is very costly. Even if such funding were allocated, the number of attorneys qualified and willing to take these cases is small, and it would take decades to appoint counsel for all those currently unrepresented. These individuals are stuck in limbo, yet they remain sentenced to death, with the knowledge that a change in governor could mean the resumption of executions. No-one should have to live under sentence of death with no prospect of judicial review.

The prosecution of a capital case clogs up the courts at every level, slowing down justice for other litigants. The cost of putting and keeping someone on death row far exceeds the cost of keeping someone in prison for life. That money could be spent so much more profitably on other things.

Please support Supervisor Fielder's resolution and urge Governor Newsom to commute all death sentences.
