

1 [Accept and Expend Federal Funds – Fiscal Year 2009 Lead Based Paint Hazard Control
2 Grant Program – 2009 Federal Recovery Act]

4 **Resolution authorizing the Mayor of the City and County of San Francisco to**
5 **retroactively accept and expend a grant from the U.S. Department of Housing and**
6 **Urban Development for lead-based paint hazard reduction in a total amount not to**
7 **exceed \$3,000,000.**

9 WHEREAS, The U.S. Department of Housing and Urban Development (HUD) has
10 awarded a Fiscal Year 2009 Lead Based Paint Hazard Control Grant to the City and County
11 of San Francisco (City) in the amount of \$3,000,000 (the Grant) as part of the Federal 2009
12 Recovery Act, for a period of not more than thirty six months for the purpose of controlling
13 lead based paint in eligible rental housing units and homeowner occupied housing units
14 constructed before 1978; and

15 WHEREAS, Under the Grant agreement HUD requires the City to submit its work
16 program and proposed budget within 60 days for HUD review and approval, and to
17 commence operation of the lead hazard reduction demonstration program funded by the
18 Grant no later than April 1, 2009; and

19 WHEREAS, MOH has prepared an Expenditure Schedule for the use of the Grant on
20 file with the Clerk of the Board of Supervisors in File No. 090479, which is hereby declared to
21 be part of this Ordinance as if set forth fully herein; and

22 WHEREAS, The grant requires a 25% match which has been reduced to 22.78% by
23 HUD because of the special stimulus purpose of this grant; and

1 WHEREAS, The City is providing an in-kind match of \$683,332, which represents the
2 City's contribution to the administration of the program for a period of three years, and

3 WHEREAS, The City will provide the required match funds through the annual
4 Community Development Block Grant budget, and

5 WHEREAS, HUD has approved an amount of \$106,530 to be included in the grant for
6 indirect costs; and

7 WHEREAS, No amendment is required to the 2008-2009 Fiscal Year Annual Salary
8 Ordinance with the acceptance of this grant; now, therefore be it,

9 RESOLVED, That the Board of Supervisors hereby authorizes the Director of MOH, on
10 behalf of the City, retroactively to accept and to expend the Grant from HUD. The Director of
11 MOH is hereby authorized to submit documentation and certifications required by HUD on
12 behalf of the City.
