3 **Ordinance authorizing settlement of the claim for attorney's fees and costs incurred by**

5 **Byard, Andrew Sirkis, National Rifle Association, Second Amendment Foundation,**  
6 **California Association of Firearm Retailers, Law Enforcement Alliance of America, and**  
7 **San Francisco Veteran Police Officers Association in litigation against the City and**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The City Attorney is hereby authorized to settle the claim for attorney's fees  
14 and costs incurred in the trial and appellate courts by plaintiffs and petitioners Paula Fiscal,  
15 Larry Barsetti, Rebecca Kidder, Dana Drenkoski, John Candido, Alan Byard, Andrew Sirkis,  
16 National Rifle Association, Second Amendment Foundation, California Association of Firearm  
17 Retailers, Law Enforcement Alliance of America, and San Francisco Veteran Police Officers  
18 Association in litigation entitled "Fiscal, et al., v. City and County of San Francisco, et al., San  
19 Francisco Superior Court, Court No. CPF-05-505960, by the payment of \$380,000.00 in  
20 attorney's fees and costs.

21 Section 2. The above-named action was filed in San Francisco Superior Court on
