

1 [Accept-Expend Federal Grant – Spousal Abuser Prosecution Program]

3 **Resolution authorizing the Department of the District Attorney of the City and County**
4 **of San Francisco to accept and expend a grant in the amount of \$102,076 through the**
5 **California Department of Justice for a program entitled “Spousal Abuser Prosecution**
6 **Program” for fiscal year 2007/2008.**

8 WHEREAS, The City and County of San Francisco desires to continue a certain project
9 designated the Spousal Abuser Prosecution Program to be funded in part from funds made
10 available through the California Department of Justice (hereafter “DOJ”); and,

11 WHEREAS, DOJ requires that the City and County of San Francisco, through the
12 Office of the District Attorney, provide no less than the necessary twenty percent cash match
13 for the grant; and

14 WHEREAS, The grant does not require an ASO amendment; and

15 WHEREAS, The Department proposes to maximize use of available grant funds on
16 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

17 **RESOLVED**, That the Board of Supervisors hereby authorizes the District Attorney of
18 the City and County of San Francisco to accept and expend funds from DOJ for the purposes
19 of spousal abuser prosecution; and, be it

20 **FURTHER RESOLVED**, That the Board of Supervisors hereby waives inclusion of
21 indirect costs in the grant budget; and be it

22 **FURTHER RESOLVED**, That the District Attorney is authorized to execute on behalf of
23 the City and County of San Francisco the necessary Grant Award Agreements for spousal
24 abuser prosecution purposes, including any extensions, augmentations or amendments
25 thereof; and be it

1 FURTHER RESOLVED, That the District Attorney is authorized and empowered to
2 execute, deliver and perform, in the name of the City and County of San Francisco, all
3 applications, contracts, agreements, amendments and payment requests necessary for the
4 purpose of securing Spousal Abuser Prosecution Program grant funds and to implement and
5 carry out the purposes specified in the applicable grant application; and be it

6 FURTHER RESOLVED, That any liability arising out of the performance of the Grant
7 Award Agreement, including civil court actions for damages, shall be the responsibility of the
8 grant recipient and the authorizing agency; and that the grant recipient and the authorizing
9 agency will hold DOJ harmless from any claims that may arise from the use of grant funds;
10 be it

11 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
12 supplant expenditures controlled by this body.
