14 Service International, Airborne, Atlantic Richfield Co., Chevron/Texaco, Shell, Signature Flight
15 Support, and Unocal, on the terms and conditions specified in those certain Settlement
16 Agreements on file with the Clerk of the Board (file no. 051814) (the
17 "Settlement Agreement");

18 Section 2. The Settlement Agreement for each of the settling parties and the actions
19 contemplated thereby are hereby approved.

20 Section 3. That the Airport Director be and hereby is authorized to take such other
21 actions as are necessary and appropriate in furtherance of this ordinance, including the






