3 **Ordinance repealing San Francisco Traffic Code sections 3.6, 10, 20, 35, 88, and 89, and**  
4 **amending San Francisco Police Code section 1320.10, to delete references to Traffic**  
5 **Zone No. 1.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Traffic Code is hereby amended by repealing Sections  
11 3.6, 10, 20, 35, 88, and 89 in their entirety:

12 **~~SEC. 3.6. TRAFFIC ZONE NO. 1.~~**

13 *That portion of the City and County of San Francisco bounded as follows: Commencing at a*  
14 *point where the southerly line of Folsom Street intersects the easterly line of Main Street, thence*  
15 *westerly along the southerly line of Folsom Street to the westerly line of Seventh Street; thence*  
16 *northerly along the westerly line of Seventh Street to a point where the prolongation of said westerly*  
17 *line of Seventh Street intersects the northerly line of Market Street; thence easterly along the northerly*  
18 *line of Market Street to a point where the said northerly line of Market Street intersects the*  
19 *prolongation of the westerly line of Jones Street; thence northerly along the westerly line of Jones*  
20 *Street to the northerly line of Bush Street; thence easterly along the northerly line of Bush Street to the*  
21 *westerly line of Kearny Street; thence northerly along the westerly line of Kearny Street to the*  
22 *northerly line of Clay Street; thence easterly along the northerly line of Clay Street to the easterly line*  
23 *of Drumm Street; thence southerly along the easterly line of Drumm Street to the northerly line of*  
24 *California Street; thence diagonally to the intersection of the southerly line of Market Street with the*

1 *easterly line of Main Street; thence southerly along the easterly line of Main Street to the point of*  
2 *commencement.*

3 **~~SEC. 10. "TRAFFIC ZONE NO. 1" TO BE SUBSTITUTED FOR "CENTRAL TRAFFIC~~**  
4 **~~DISTRICT."~~**

5 *Whenever any Section of the San Francisco Municipal Code refers to or mentions the "Central*  
6 *Traffic District," said Section shall hereafter be read and interpreted as if the words "Traffic Zone No.*  
7 *1" were substituted therefor.*

8 **~~SEC. 20. REFUSAL TO MOVE VEHICLE.~~**

9 *It shall be unlawful for any person in charge of any vehicle standing along or near the curb*  
10 *upon any street within Traffic Zone No. 1, or any business district, to fail, refuse or neglect to remove*  
11 *such vehicle from said curb when requested to do so by any Police Officer or Parking Control Officer.*

12 **~~SEC. 35. LEFT-HAND TURNS PROHIBITED IN TRAFFIC ZONE NO. 1.~~**

13 *Except for left hand turns that are in conformity with the normal flow of traffic on a "One way*  
14 *Traffic Street," it shall be unlawful to make a left hand turn into or from any public or private garage,*  
15 *parking lot, service station or private driveway, on any street within Traffic Zone No. 1, after the*  
16 *erection thereat of appropriate signs giving notice of the prohibition of such left hand turns, and the*  
17 *Department of Parking and Traffic is hereby authorized to erect or cause to be erected appropriate*  
18 *signs giving notice of such prohibition.*

19 **~~SEC. 88. CERTAIN VEHICLES PROHIBITED IN TRAFFIC ZONE NO. 1.~~**

20 *It shall be unlawful for the operator of any vehicle primarily designed or used for the purpose of*  
21 *advertising to drive such vehicle in Traffic Zone No. 1 between the hours of 7:00 a.m. and 7:00 p.m. of*  
22 *any day; provided, said vehicle shall not be driven in said traffic zone between the hours of 7:00 p.m. of*  
23 *any day and 7:00 a.m. of the following day without permission from the Chief of Police.*

1            ~~SEC. 89. HORSE DRAWN VEHICLES PROHIBITED IN TRAFFIC ZONE NO. 1~~  
2 ~~PERMISSION DURING CERTAIN HOURS.~~


3            ~~It shall be unlawful for the operator of any horse drawn vehicle to drive the same in Traffic~~  
4 ~~Zone No. 1 between the hours of 7:00 a.m. and 7:00 p.m. of any day, excepting Sundays, except upon~~  
5 ~~authorization of the Chief of Police.~~

6            Section 2. The San Francisco Police Code is hereby amended by amending Section  
7 1320.10, to read as follows:

8            **SEC. 1320.10. EXEMPTION FROM PROHIBITION OF SELLING FROM VEHICLES**  
9 **IN ~~TRAFFIC ZONE NO. ONE~~ AND BUSINESS DISTRICTS.**

10           An operator of a mobile catering vehicle shall be allowed to offer for sale at retail or  
11 give away any food or drink for human consumption ~~within Traffic Zone No. 1 as defined in City's~~  
12 ~~Traffic Code or~~ in any business district.




