3 **Resolution retroactively authorizing the Office of the District Attorney to accept**  
4 **retroactively and expend a grant in the amount of \$150,000 from the California Office of**  
5 **Criminal Justice Planning for the operation of the Statutory Rape Vertical Prosecution**  
6 **Program.**

8 WHEREAS, The District Attorney's Office and the City and County of San Francisco  
9 desire to continue a certain project designated the Statutory Rape Vertical Prosecution  
10 Program with funds made available through the California Office of Criminal Justice Planning  
11 (OCJP); and,

12 WHEREAS, The District Attorney proposes to maximize use of available grant funds on  
13 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

14 RESOLVED, That the District Attorney of the City and County of San Francisco is  
15 authorized on behalf of the City and County of San Francisco to accept and expend funds  
16 from OCJP to continue the Statutory Rape Vertical Prosecution Program; and be it

17 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
18 indirect costs in the grant budget; and be it

19 FURTHER RESOLVED, That in the event the OCJP consents to continue funding the  
20 Statutory Rape Vertical Prosecution Program, the District Attorney of the City and County of  
21 San Francisco is authorized to execute any amendments or augmentations of said program  
22 except as any amendment or augmentation would increase any hard matching fund  
23 obligations of the City and County of San Francisco pursuant to the contract; and be it

1 FURTHER RESOLVED, That the grant funds received hereunder shall not be used to  
2 supplant local funds that would, in the absence of the Statutory Rape Vertical Prosecution  
3 Program, be made available to support the prosecution of statutory rape; and be it

4 FURTHER RESOLVED, That it is agreed that any liability arising out of the  
5 performance of this Grant Award contract including Civil Court actions for damages shall be  
6 the responsibility of the grantee and the authorizing agency. The State of California and  
7 OCJP disclaim responsibility for any such liability.




