Ordinance authorizing settlement of the lawsuit filed by Damena Page against the City and County of San Francisco and all allegations in related Government Claim No. 25-00817 for \$75,000; the lawsuit was filed on June 23, 2023, in United States District Court for the Northern District of California, Case No. 23-cv-03129; entitled <a href="Damena Page v. City and County of San Francisco">Damena Page v. City and County of San Francisco</a>, et al.; the lawsuit and Government Claim involve alleged civil rights violations.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled <u>Damena Page v. City and County of San Francisco</u>, et al., United States District Court for the Northern District of California, Case No. 23-cv-03129, together with all allegations contained in Government Claim No. 25-00817, by the payment of \$75,000. The lawsuit and Government Claim involve alleged civil rights violations.
