7 **authorizing the Human Services Agency to accept and expend a grant in the amount of**
8 **~~\$28,141,437~~ \$26,505,777 from the United States Department of Health and Human**
9 **Services, TANF Emergency Contingency Fund, as part of the American Recovery and**
10 **Reinvestment Act of 2009, to sponsor the Mayor’s Jobs NOW Program.**

15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. **Grant-funded Positions; Amendment to FY 2009-2010 Annual Salary Ordinance.**

17 The hereinafter designated section and item of the Annual Salary Ordinance, FY 2009
18 2010 is hereby amended so that the same shall read as follows:

4 In the event that this ordinance is approved prior to the adoption of the Annual Salary
5 Ordinance for FY 2009-2010, the Controller shall amend the Interim Annual Salary
6 Ordinance to reflect this position authority.

8 **Section 2. Authorization to Accept and Expend Funds.**

9 This Ordinance authorizes the Human Services Agency to accept and expend a grant
10 in the amount of ~~\$28,141,437~~ \$26,505,777 for the operation of a subsidized employment
11 program known as Jobs NOW. The United States Department of Health and Human Services
12 provides funds to the City and County of San Francisco, through the California
13 Department of Social Services, to operate the California Work Opportunity and
14 Responsibility to Kids (CalWORKs) Program. CalWORKs funds include local state
15 dollars as well as federal Temporary Aid to Needy Families (TANF) dollars. With the
16 passage of the American Recovery and Reinvestment Act (ARRA), Congress
17 expanded the kinds of expenses that can be reimbursed with TANF funds. HSA will be
18 able to claim reimbursement for 80% of expenses associated with subsidized
19 employment programs and related ancillary services for current and former recipients
20 of CalWORKs aid. Pending state guidance, HSA may also be authorized to spend
21 TANF funds on a broader population as well, including non-custodial parents and
22 families earning income less than 200% of the Federal Poverty Level.
