18 beer and wine license, to Matthew R. Shelton for Shelton Theater, located at 533 Sutter  
19 Street will serve the public convenience and necessity of the people of the City and  
20 County of San Francisco.

21 Conditions: 1) The petitioner(s) shall be responsible for maintaining free of litter  
22 the area adjacent to the premises over which they have control; 2) The petitioner(s)  
23 shall police the area under their control in an effort to prevent the loitering of persons



