3 **Ordinance authorizing settlement of the lawsuit filed by Nicole Spencer against the City**  
4 **and County of San Francisco for \$225,000; the lawsuit was filed on January 18, 2021, in**  
5 **San Francisco Superior Court, Case No. CGC-21-589457; entitled Nicole Spencer v. City**  
6 **and County of San Francisco; the lawsuit involves an employment dispute.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Nicole Spencer v. City and County of  
11 San Francisco, San Francisco Superior Court, Case No. CGC-21-589457, by the payment of  
12 \$225,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 January 28, 2021, and the following parties were named in the lawsuit: Plaintiff: Nicole  
16 Spencer; Defendant: City and County of San Francisco.
