3 **Resolution commending California Trout and Pacific Gas and Electric on the success**  
4 **of "Trout Day 2005".**

6 WHEREAS, Trout Day 2005 is the second annual celebration of the restoration of  
7 Lake Merced and the return of family fishing to its shores; and,

8 WHEREAS, Lake Merced, in the southwestern corner of the City of San Francisco,  
9 was once one of the finest urban fisheries in the United States, but in the late 1990s, the lake  
10 became increasingly degraded as a result of excessive groundwater pumping from its  
11 underground aquifer; and,

12 WHEREAS, In January 2001, California Trout, a conservation organization, filed a  
13 petition that requested appropriate limitations on groundwater pumping to protect Lake  
14 Merced; and,

15 WHEREAS, Since then, California Trout has worked collaboratively with the primary  
16 water users in a positive settlement process; and,

17 WHEREAS, Thanks to the settlement, Lake Merced is on its way to a full recovery;  
18 and,

19 WHEREAS, Water depths are near historical levels and non-native plant controls have  
20 begun, and water monitoring and testing indicate that excellent conditions are returning; and,

21 WHEREAS, Outdoor recreation and trout fishing at the Lake have also returned and  
22 the sight of Lake Merced full of water and children enjoying the lake is great for the City and  
23 County of San Francisco; and,

24 WHEREAS, This year Pacific Gas and Electric has joined California Trout as a  
25 featured sponsor of Trout Day; now therefore be it,


