17 Alcoholic Beverage Control issue the liquor license with a condition; and

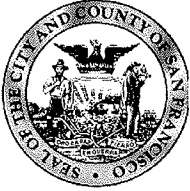
18 WHEREAS, The condition recommended by the Police Department is the

23 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
24 hereby determines that a Type-64 special on-sale general theater liquor license to ODC,
