10 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Delegation.

13 State law allows the Board of Supervisors to contract on behalf of the Sheriff to provide  
14 supplemental law enforcement services to private individuals or private entities at special  
15 events or occurrences that happen on an occasional basis. Under this Chapter 10A, the  
16 Board of Supervisors is delegating to the Sheriff the Board’s authority under state law to  
17 contract with private individuals or private entities to provide supplemental Sheriff’s law  
18 enforcement services at special events or occurrences that happen on an occasional basis.

19

20 Section 2. The Administrative Code is hereby amended by adding Chapter 10A,  
21 consisting of Sections 10A.1, 10A.2, 10A.3, 10A.4, and 10A.5, to read as follows:

22

23 **10A.1. DEFINITIONS.**

24 For purposes of this Chapter 10A, the following definitions shall apply:

25 “City” means the City and County of San Francisco.

1 "Department" means the Sheriff's Department.

2 "Event Organizer" means the person, firm, corporation, or organization hosting a cultural,  
3 recreational, entertainment, arts, educational, civic, or religious event, including festivals and block  
4 parties, and seeking additional personnel, equipment, or materials of the Department, for law  
5 enforcement purposes within the City.

6 "Security Plan" means a plan drafted by the Event Organizer that adequately addresses the  
7 safety of persons and property associated with the event that is the subject of the request for  
8 Department services. This definition of "Security Plan" does not limit the discretion of the Department  
9 to impose more stringent requirements for a Security Plan as circumstances warrant.

10 "Sheriff" means the Sheriff or the Sheriff's designee.

11  
12 **10A.2. REQUEST FOR SHERIFF'S SERVICES.**

13 (a) Any prospective Event Organizer desiring supplemental Department law enforcement  
14 services within the City for their event, may request the Sheriff to provide Department personnel to  
15 perform such services. Any request for such services shall include a Security Plan.

16 (b) If the Sheriff approves the request for Department services, the Sheriff shall include with the  
17 approval a written staffing plan that includes the number of personnel to be detailed in response to the  
18 request, the approximate personnel location assignments, the anticipated shifts for all detailed  
19 personnel, and the contact information of the Department employee to be assigned to supervise those  
20 personnel.

21 (c) If the Sheriff determines that the requested Department services will require dispatch  
22 services from the Department of Emergency Management, the Sheriff shall notify the Executive  
23 Director of the Department of Emergency Management (or designee), who may detail such personnel  
24 for such services in the number the Executive Director or designee determines to be necessary to  
25 perform the dispatch services.

1           (d) An Event Organizer whose request for Department services has been denied may submit a  
2 request for reconsideration of the denial to the Sheriff in writing within 10 days of receipt of the denial.  
3 An Event Organizer whose request for Department services has been approved may submit a request  
4 for reconsideration of the written staffing plan required under subsection (b) to the Sheriff in writing  
5 within 10 days of receipt of the written staffing plan.

6           (e) The Sheriff shall inform the Event Organizer in writing of the Sheriff's final decision  
7 regarding any request for reconsideration made under subsection (d) within 10 days of receipt of the  
8 request for reconsideration.

9  
10           **SEC. 10A.3. PAYMENT FOR SERVICES.**

11           (a) The Event Organizer shall pay to the Department such sums of money as may be necessary  
12 to pay for the additional services, including any dispatch services provided by the Department of  
13 Emergency Management.

14           (1) The payment shall include a component for Department services, computed based  
15 upon the rate paid or payable to those uniformed officers of the Department actually performing  
16 services at the time they are to perform such additional services, and the cost of additional equipment  
17 and materials expended, together with an administrative overhead charge to cover the proportionate  
18 percentage of the Department's administrative costs that are attributable in the Department's  
19 reasonable discretion to the work performed pursuant to the request.

20           (2) The payment shall also include a component for any dispatch services provided by  
21 the Department of Emergency Management, which shall be computed by the Department of Emergency  
22 Management based on the rate paid or payable to the dispatch personnel actually performing services  
23 at the time they are to perform such additional duties.

24           (b) The Department shall provide an estimate of the payment for such services, including an  
25 estimate from the Department of Emergency Management for any dispatch services, to the Event

1 Organizer within a reasonable time prior to the date service is to be rendered. The Event Organizer  
2 shall deposit the amount of estimated funds with the Department prior to the time that the Department  
3 renders the requested service. The Department may waive the deposit requirement if the Department  
4 reasonably believes that a waiver is justified based on criteria that the Sheriff shall determine and post  
5 on the Department website at least 30 days before accepting any requests for services under this  
6 Chapter.

7 (c) Within a reasonable time after the services are rendered, the Sheriff shall determine the  
8 amount of payment due. The amount due shall be based on actual services performed by the  
9 Department and any dispatch services by the Department of Emergency Management.

10 (1) If the deposit pursuant to subsection (b) is insufficient to cover the actual cost of  
11 Department and dispatch services, the Sheriff shall notify the Event Organizer by United States mail to  
12 the address listed on the request for such services, and the Event Organizer shall have 10 days from  
13 receipt of the bill to pay the balance.

14 (2) If the amount deposited pursuant to subsection (b) exceeds the actual cost of  
15 Department and dispatch services, the Sheriff shall authorize and arrange payment of a refund of the  
16 excess to the Event Organizer.

17 (d) The Department shall deposit with the Treasurer such sums as received in a special account  
18 designated public facilities overtime account; provided, however, that the amount for the Department  
19 representing administrative overhead shall be deposited to the general fund unappropriated balance of  
20 funds, and the amount for the Department of Emergency Management's dispatch services shall be  
21 transferred to the Department of Emergency Management.

22 (e) The Event Organizer shall indemnify, hold harmless, and defend the City, the Department,  
23 the Department of Emergency Management, and all City officers, agents, and employees, from and  
24 against all liability, judgments, or claims for personal injury, including but not limited to bodily  
25

1 injuries, or other claims, including but not limited to false arrest and false imprisonment, caused by or  
2 purportedly caused by such personnel in the rendering of such services.

3 (f) The City shall not waive payment for Department or dispatch services provided pursuant to  
4 this Chapter 10A except by ordinance.

5  
6 **SEC. 10A.4. COMPENSATION.**

7 (a) For services performed in excess of the basic week of service, Department members shall be  
8 compensated on the basis of time and one-half in accordance with the ratio that said excess service  
9 bears to the basic week of service and the annual compensation as determined under Section A8.400 of  
10 the City Charter and applicable memoranda of understanding.

11 (b) Requested services from the Department and the Department of Emergency Management  
12 shall be compensated upon the basis of four hours per employee minimum per assignment.

13 (c) For services performed in excess of the basic work week, Department of Emergency  
14 Management personnel shall be compensated on the basis of time and one-half in accordance with the  
15 ratio which said excess service bears to the basic week of service and the annual compensation  
16 provided therefor in applicable memoranda of understanding.

17 (d) A member of the Department or Department of Emergency Management, detailed to  
18 perform services pursuant to this Chapter 10A, shall not be entitled to any additional overtime benefits  
19 other than those provided in this Section 10A.4.

20  
21 **SEC. 10A.5. UNDERTAKING FOR THE GENERAL WELFARE.**

22 In enacting and implementing this Chapter 10A, the City is assuming an undertaking only to  
23 promote the general welfare. It is not assuming, nor is it imposing on its officers and employees, an  
24 obligation for breach of which it is liable in money damages to any person who claims that such breach  
25 proximately caused injury.

1 Section 3. Effective Date. This ordinance shall become effective 30 days after  
2 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
3 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
4 of Supervisors overrides the Mayor's veto of the ordinance.

Existing Law

Existing law authorizes the Board of Supervisors to contract with private entities to provide supplemental law enforcement services at special events or occurrences that happen on an occasional basis.

Amendments to Current Law

This ordinance would delegate to the Sheriff the authority to contract with private entities to provide supplemental Sheriff's services at special events or occurrences that happen on an occasional basis. This ordinance would require that the event organizer include a security plan with their request for services and that the Sheriff develop a staffing plan that includes, if needed, Department of Emergency Management dispatch services. Finally, this ordinance would delineate payment and compensation requirements.



3 **Ordinance amending the Administrative Code to authorize the Sheriff to contract with**  
4 **private entities to provide supplemental law enforcement services.**

10 Be it ordained by the People of the City and County of San Francisco:

11

12 Section 1. Delegation.

13 State law allows the Board of Supervisors to contract on behalf of the Sheriff to provide  
14 supplemental law enforcement services to private individuals or private entities at special  
15 events or occurrences that happen on an occasional basis. Under this Chapter 10A, the  
16 Board of Supervisors is delegating to the Sheriff the Board’s authority under state law to  
17 contract with private individuals or private entities to provide supplemental Sheriff’s law  
18 enforcement services at special events or occurrences that happen on an occasional basis.

19

20 Section 2. The Administrative Code is hereby amended by adding Chapter 10A,  
21 consisting of Sections 10A.1, 10A.2, 10A.3, 10A.4, and 10A.5, to read as follows:

22

23 **10A.1. DEFINITIONS.**

24 For purposes of this Chapter 10A, the following definitions shall apply:

25 “City” means the City and County of San Francisco.

1 "Department" means the Sheriff's Department.

2 "Event Organizer" means the person, firm, corporation, or organization hosting a cultural,  
3 recreational, entertainment, arts, educational, civic, or religious event, including festivals and block  
4 parties, and seeking additional personnel, equipment, or materials of the Department, for law  
5 enforcement purposes within the City.

6 "Security Plan" means a plan drafted by the Event Organizer that adequately addresses the  
7 safety of persons and property associated with the event that is the subject of the request for  
8 Department services. This definition of "Security Plan" does not limit the discretion of the Department  
9 to impose more stringent requirements for a Security Plan as circumstances warrant.

10 "Sheriff" means the Sheriff or the Sheriff's designee.

11  
12 **10A.2. REQUEST FOR SHERIFF'S SERVICES.**

13 (a) Any prospective Event Organizer desiring supplemental Department law enforcement  
14 services within the City for their event, may request the Sheriff to provide Department personnel to  
15 perform such services. Any request for such services shall include a Security Plan.

16 (b) If the Sheriff approves the request for Department services, the Sheriff shall include with the  
17 approval a written staffing plan that includes the number of personnel to be detailed in response to the  
18 request, the approximate personnel location assignments, the anticipated shifts for all detailed  
19 personnel, and the contact information of the Department employee to be assigned to supervise those  
20 personnel.

21 (c) If the Sheriff determines that the requested Department services will require dispatch  
22 services from the Department of Emergency Management, the Sheriff shall notify the Executive  
23 Director of the Department of Emergency Management (or designee), who may detail such personnel  
24 for such services in the number the Executive Director or designee determines to be necessary to  
25 perform the dispatch services.

1           (d) An Event Organizer whose request for Department services has been denied may submit a  
2 request for reconsideration of the denial to the Sheriff in writing within 10 days of receipt of the denial.  
3 An Event Organizer whose request for Department services has been approved may submit a request  
4 for reconsideration of the written staffing plan required under subsection (b) to the Sheriff in writing  
5 within 10 days of receipt of the written staffing plan.

6           (e) The Sheriff shall inform the Event Organizer in writing of the Sheriff's final decision  
7 regarding any request for reconsideration made under subsection (d) within 10 days of receipt of the  
8 request for reconsideration.

9  
10           **SEC. 10A.3. PAYMENT FOR SERVICES.**

11           (a) The Event Organizer shall pay to the Department such sums of money as may be necessary  
12 to pay for the additional services, including any dispatch services provided by the Department of  
13 Emergency Management.

14           (1) The payment shall include a component for Department services, computed based  
15 upon the rate paid or payable to those uniformed officers of the Department actually performing  
16 services at the time they are to perform such additional services, and the cost of additional equipment  
17 and materials expended, together with an administrative overhead charge to cover the proportionate  
18 percentage of the Department's administrative costs that are attributable in the Department's  
19 reasonable discretion to the work performed pursuant to the request.

20           (2) The payment shall also include a component for any dispatch services provided by  
21 the Department of Emergency Management, which shall be computed by the Department of Emergency  
22 Management based on the rate paid or payable to the dispatch personnel actually performing services  
23 at the time they are to perform such additional duties.

24           (b) The Department shall provide an estimate of the payment for such services, including an  
25 estimate from the Department of Emergency Management for any dispatch services, to the Event

1 Organizer within a reasonable time prior to the date service is to be rendered. The Event Organizer  
2 shall deposit the amount of estimated funds with the Department prior to the time that the Department  
3 renders the requested service. The Department may waive the deposit requirement if the Department  
4 reasonably believes that a waiver is justified based on criteria that the Sheriff shall determine and post  
5 on the Department website at least 30 days before accepting any requests for services under this  
6 Chapter.

7 (c) Within a reasonable time after the services are rendered, the Sheriff shall determine the  
8 amount of payment due. The amount due shall be based on actual services performed by the  
9 Department and any dispatch services by the Department of Emergency Management.

10 (1) If the deposit pursuant to subsection (b) is insufficient to cover the actual cost of  
11 Department and dispatch services, the Sheriff shall notify the Event Organizer by United States mail to  
12 the address listed on the request for such services, and the Event Organizer shall have 10 days from  
13 receipt of the bill to pay the balance.

14 (2) If the amount deposited pursuant to subsection (b) exceeds the actual cost of  
15 Department and dispatch services, the Sheriff shall authorize and arrange payment of a refund of the  
16 excess to the Event Organizer.

17 (d) The Department shall deposit with the Treasurer such sums as received in a special account  
18 designated public facilities overtime account; provided, however, that the amount for the Department  
19 representing administrative overhead shall be deposited to the general fund unappropriated balance of  
20 funds, and the amount for the Department of Emergency Management's dispatch services shall be  
21 transferred to the Department of Emergency Management.

22 (e) The Event Organizer shall indemnify, hold harmless, and defend the City, the Department,  
23 the Department of Emergency Management, and all City officers, agents, and employees, from and  
24 against all liability, judgments, or claims for personal injury, including but not limited to bodily  
25



1 injuries, or other claims, including but not limited to false arrest and false imprisonment, caused by or  
2 purportedly caused by such personnel in the rendering of such services.

3 (f) The City shall not waive payment for Department or dispatch services provided pursuant to  
4 this Chapter 10A except by ordinance.

5  
6 **SEC. 10A.4. COMPENSATION.**

7 (a) For services performed in excess of the basic week of service, Department members shall be  
8 compensated on the basis of time and one-half in accordance with the ratio that said excess service  
9 bears to the basic week of service and the annual compensation as determined under Section A8.400 of  
10 the City Charter and applicable memoranda of understanding.

11 (b) Requested services from the Department and the Department of Emergency Management  
12 shall be compensated upon the basis of four hours per employee minimum per assignment.

13 (c) For services performed in excess of the basic work week, Department of Emergency  
14 Management personnel shall be compensated on the basis of time and one-half in accordance with the  
15 ratio which said excess service bears to the basic week of service and the annual compensation  
16 provided therefor in applicable memoranda of understanding.

17 (d) A member of the Department or Department of Emergency Management, detailed to  
18 perform services pursuant to this Chapter 10A, shall not be entitled to any additional overtime benefits  
19 other than those provided in this Section 10A.4.

20  
21 **SEC. 10A.5. UNDERTAKING FOR THE GENERAL WELFARE.**

22 In enacting and implementing this Chapter 10A, the City is assuming an undertaking only to  
23 promote the general welfare. It is not assuming, nor is it imposing on its officers and employees, an  
24 obligation for breach of which it is liable in money damages to any person who claims that such breach  
25 proximately caused injury.

1 Section 3. Effective Date. This ordinance shall become effective 30 days after  
2 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
3 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
4 of Supervisors overrides the Mayor's veto of the ordinance.
