

1 [Accept and expend grant – Expanding services for mentally ill parolees.]

3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**
4 **and expend retroactively a grant from the California Department of Corrections and**
5 **Rehabilitation (CDCR) in the amount of \$1,925,719 to expand the City’s treatment**
6 **capacity for mentally ill parolees; for the period of June 1, 2009 through June 30, 2012,**

8 WHEREAS, DPH was awarded a grant from CDCR in the amount of \$1,925,719 for a
9 project entitled Integrated Services for Mentally Ill Parolee-Clients; for the period of June 1,
10 2009 through June 30, 2012; and,

11 WHEREAS, The purpose of this grant is to expand the City’s treatment capacity for
12 mentally ill parolees through various services including intensive case management, skills
13 training, advocacy and recovery support; and,

14 WHEREAS, This grant is nearly identical to a CDCR grant for the same amount of
15 funding for the same time period awarded to DPH in April, 2009, allowing DPH to increase
16 services for mentally ill parolees in San Francisco by 45 additional treatment slots (25 through
17 the first grant and 20 for this second one); and,

18 WHEREAS, DPH will subcontract with Walden House, a community-based
19 organization with a 39-year history of providing comprehensive services to parolees and
20 probationers, in the amount of \$1,587,570 for the period of the grant; and,

21 WHEREAS, The grant does not require an ASO amendment and reimburses DPH for
22 two existing positions, including Epidemiologist II (Job Class #2803), and Health Worker II
23 (Job Class #2586) both at .50 FTE; the Project Director’s time at .10 FTE will be provided in-
24 kind; and,

1 WHEREAS, The grant budget includes a provision for indirect costs in the amount of
2 \$31,569; now, therefore, be it

3 RESOLVED, That DPH is hereby authorized to accept and expend retroactively a grant
4 in the amount of \$1,925,719 from CDCR; and, be it

5 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
6 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
7 be it

8 FURTHER RESOLVED, That the Controller is directed to designate the positions
9 funded under this agreement as a "G" or grant-funded position which would terminate when
10 the agreement expires.


11 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
12 agreement on behalf of the City.




