 9 WHEREAS, The Recreation and Park Department, acting in concert with the Recreation and  
 10 Park Commission, desires to purchase for open space purposes that parcel identified as Lot No. 67 in  
 11 Assessor's Block 2923 as highlighted on the map labelled Exhibit "A", a copy of which is on file  
 12 with the Clerk of the Board of Supervisors in file no. 000931; and,

 14 WHEREAS, The Director of Property has determined that the market value of the subject  
 15 property exceeds the \$200,000 which has been agreed to by Florence G. Alberts and Burton H.  
 16 Alberts, as Trustees; and,

 18 WHEREAS, The General Manager of the Recreation and Park Department and the Director  
 19 of Property recommend the acquisition of the subject property pursuant to an Agreement for Purchase  
 20 and Sale of Real Estate, a copy of which is on file with the Clerk of the Board of Supervisors in file  
 21 no. 000931; and,

 23 WHEREAS, The City Planning Department reported in Case No. 97.118M, a copy of which  
 24 is on file with the Clerk of the Board of Supervisors in file no. 000931, that the proposed  
 25 acquisition and park expansion is in conformity with the City's General Plan and consistent with the  
 (Real Estate)


2 **RESOLVED**, That the Board of Supervisors adopts as its own and incorporates by reference  
3 herein, as though fully set forth, the findings made by the Department of City Planning in its Case  
4 No. 97.119M that the acquisition of said real property is in conformity with the General Plan and  
5 consistent with the Eight Priority Policies of City Planning Code Section 101.1; and, be it

7 **FURTHER RESOLVED**, That in accordance with the recommendations of the Recreation  
8 and Park Commission, General Manager of the Recreation and Park Department and the Director of  
9 Property, this Board hereby approves the acquisition of the subject property for a total of \$206,000  
10 including title insurance and closing costs and authorizes the Director of Property to accept the grant  
11 deed and execute any other necessary documents to acquire the subject property from the Florence G.  
12 Alberts and Burton H. Alberts Living Trust, to be paid from the Fiscal Year appropriation listed  
13 below, and to do all things and execute and deliver any and all escrow instructions or other  
14 documents which the Director of Property or the City Attorney may deem necessary or advisable in  
15 order to consummate the purchase of Lot 67 in Assessor's Block 2923. Said acquisition shall be  
16 subject to the certification of funds by the Controller pursuant to Section 3.105 of the Charter.


