13 a minimum of five years professional experience in the State of California as one of the
14 following: Certified Public Accountant (CPA) or Public Accountant (PA); licensed Real Estate
15 Broker; Attorney; or a Property Appraiser accredited by a nationally recognized professional
16 organization, or Property Appraiser certified by the Office of Real Estate Appraisers; or he or
17 she is a current member of an assessment appeals board. *Pursuant to Section 1623 the
18 three year term will end on the first Monday in September, for the unexpired portion of a three-
19 year term ending September 7, 2015.

20 Daniel Hershkowitz, seat 5, succeeding John McGary, term expired, must meet the
