

1 [FY 2002-03 California Constitution Appropriations Limit.]

3 **Resolution establishing the appropriations limit for Fiscal Year 2002-03 pursuant to**
4 **California Constitution Article XIII B.**

6 WHEREAS, Article XIII B of the California Constitution provides that the annual
7 appropriations of the City and County of San Francisco which are subject to said Article may
8 not exceed the Appropriations Limit for the prior year, with adjustments as provided in said
9 Article XIII B; and

10 WHEREAS, The California Government Code, Section 7901, defines the terms, and
11 Section 7902 (b) sets forth the equations to be used to determine the City and County of San
12 Francisco's annual Appropriations Limit, according to the following formula:

13 "(b) For the 1981-82 fiscal year and each year thereafter, the appropriations limit of the
14 state and each local jurisdiction shall equal the appropriations limit for the prior fiscal year
15 multiplied by the lesser of the change in cost of living for the calendar year in which the fiscal
16 year begins or the change in California per capita personal income for the calendar year
17 preceding the beginning of the fiscal year for which the appropriations limit is to be
18 determined, the product multiplied by the change in population of the local jurisdiction for the
19 calendar year preceding the beginning of the fiscal year for which the appropriations limit is to
20 be determined, and adjusted for other changes required or permitted by Article XIII B of the
21 California Constitution."; and

22 WHEREAS, The resulting calculation establishing the City and County of San

2 WHEREAS, For future Appropriations Limit calculations pursuant to said Article, the
3 City will use the gross appropriations limit of \$1,751,554,849; and

4 WHEREAS, This matter has been considered at a regularly scheduled meeting of the
5 Board of Supervisors for the City and County of San Francisco; and

6 WHEREAS, The documentation used to determine the Appropriations Limit for the City
7 and County of San Francisco for fiscal year 2002-03 was available for public inspection in the
8 office of the Clerk of the Board of Supervisors for at least fifteen (15) days prior to said
9 regularly scheduled meeting; now, therefore, be it

11 RESOLVED, That the City and County of San Francisco elects to use the percentage
12 “change in the cost of living” as measured by the increase in the local assessment role due to
13 non-residential new construction from the previous year and elects to use the percentage
14 increase in population as measured by the San Francisco-Oakland-San Jose Consolidated
15 Metropolitan Statistical Area from the previous year for the purpose of computation of its
16 Appropriations Limit pursuant to Article XIII B of the California Constitution for fiscal year
17 2002-03; and, be it

19 FURTHER RESOLVED, That the net appropriations limit for fiscal year 2002-03 is
20 established at \$1,751,554,849.
