1 [Honoring Local Restaurants During Restaurant Appreciation Month.]

2  
3 **Ordinance amending the San Francisco Health Code by adding Section 456.7 requiring**  
4 **the San Francisco Health Department to declare one month out of the year “Restaurant**  
5 **Appreciation Month” to honor certain local restaurants and to create an application and**  
6 **selection process to identify qualifying restaurants.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Findings. The Board of Supervisors of the City and County of San  
12 Francisco hereby find and determine that:

13 (a) San Francisco restaurants are one of the top reasons for visiting San Francisco,  
14 according to the San Francisco Convention and Visitors Bureau.

15 (b) San Francisco is the birthplace of the Irish Coffee, the martini, cioppino, chicken  
16 tetrazzini, Joe’s Special, Crab Louis and sourdough.

17 (c) San Francisco is also the birthplace for the organic food revolution and is the  
18 foundation of California cuisine.

19 (d) San Francisco became the second U.S. city and the only West Coast city to  
20 have a Michelin Guide, with more than 300 restaurants receiving the coveted stars or making  
21 the cut to be included in the prestigious guide.

22 (e) San Francisco boasts more restaurants per capita than any other cosmopolitan  
23 city in the U.S.

24 (f) Readers of *Bon Appétit* consistently name San Francisco as the nation’s top city  
25 for dining out.

1 (g) San Francisco's diverse population and cultural heritage are reflected by the  
2 diverse culinary offerings of San Francisco's highly acclaimed restaurants.

3 (h) Diners can partake of San Francisco's rich cultural diversity in a multitude of  
4 neighborhood restaurants, from Afghan to Armenian, Turkish to Tibetan, making available  
5 every cuisine one could imagine.

6 Section 2. The San Francisco Health Code is hereby amended by adding Section  
7 456.7, to read as follows:

8 **SEC. 456.7. RESTAURANT APPRECIATION MONTH.**

9 (a) The Department of Public Health shall:

10 1. Declare October as Restaurant Appreciation Month.

11 2. Establish criteria and an application and selection process to identify local  
12 restaurants that contribute to the vitality of San Francisco. The selected restaurants shall be  
13 recognized during at least one public event held during Restaurant Appreciation Month. The  
14 Mayor, individual members of the Board of Supervisors, and the general public may nominate  
15 restaurants for recognition.
