4 **Ordinance retroactively authorizing the Office of the Chief Medical Examiner to accept**
5 **and expend a grant in the amount of \$1,086,740.83 from the California Department of**
6 **Public Health, Substance and Addiction Prevention Branch; and amending Ordinance**
7 **No. 145-23 (Annual Salary Ordinance for Fiscal Years (FYs) 2023-2024 and 2024-2025)**
8 **to provide for and authorizing the addition of grant-funded temporary Class 2403**
9 **Forensic Laboratory Analyst, Class 2456 Forensic Toxicologist, and Class 2457**
10 **Forensic Toxicologist Supervisor positions, as required, for the period beginning**
11 **December 1, 2023, through June 30, 2028.**

17 Be it ordained by the People of the City and County of San Francisco:

18 **Section 1. Findings.**

19 (a) The California Department of Public Health (CDPH) has a mission to protect the
20 health of all Californians, which includes reducing rates of drug misuse and overdose.
21

22 (b) CDPH’s Overdose Prevention Initiative, under CDPH’s Substance and Addiction
23 Prevention Branch, receives federal funding from the Centers for Disease Control and
24 Prevention to address this significant public concern In California.
25

1 (c) San Francisco's Office of the Chief Medical Examiner has applied to CDPH for, and
2 expects to receive, a grant to provide enhanced forensic toxicology services in order to
3 monitor novel psychoactive substances (NPS) prevalence and perform assessment studies
4 with subsequent reporting to policymakers and stakeholders.

5 (d) The grant award period is from December 1, 2023 through June 30, 2028.
6

7 **Section 2. Authorization to accept and expend grant funds.**

8 (a) The Board of Supervisors hereby authorizes the Office of the Chief Medical
9 Examiner to retroactively accept and expend, on behalf of the City and County of San
10 Francisco, grant funds from the CDPH Substance and Addiction Prevention Branch in the
11 amount of \$1,086,740.83, to provide enhanced forensic toxicology services in order to monitor
12 ~~novel psychoactive substances (NPS)~~ prevalence and perform assessment studies with
13 subsequent reporting to policymakers and stakeholders.

14 (b) The Board of Supervisors hereby authorizes the Office of the Chief Medical
15 Examiner to maximize use of available grant funds on program expenditures by not including
16 indirect costs in the grant budget, and by waiving indirect costs.

17 (c) The Board of Supervisors hereby authorizes the Office of the Chief Medical
18 Examiner, or the Office of the Chief Medical Examiner's designee, to furnish whatever
19 additional information or assurances CDPH may request in connection with the Substance
20 and Addiction Prevention Branch grant, to execute any and all agreements or other
21 documents, and to take any other steps necessary to accept, distribute and expend the grant
22 funds.


