2 APPROVING AND AUTHORIZING THE APPROPRIATION OF UP TO \$984,850 FROM THE  
3 DOWNTOWN PARK SPECIAL FUND FOR THE PROPOSED ENHANCEMENTS TO THE MID-  
4 EMBARCADERO MUSIC CONCOURSE SITE.

6 WHEREAS, the Board of Supervisors of San Francisco, on September 17,  
7 1985, approved the creation of a Downtown Park Special Fund, Planning Code  
8 Section 139, establishing a special fund to be used solely for the  
9 acquisition and development of public recreation and park facilities for  
10 use by the daytime population of the C-3 Use Districts; and

11 WHEREAS, Planning Code Section 139(f) provides that a special fund  
12 shall be created entitled the Downtown Park Fund ("Fund") which shall be  
13 administered and allocated jointly by the City Planning Commission and the  
14 Recreation and Park Commission acting jointly for the acquisition of  
15 property for park use and/or development of property for park use; and

16 WHEREAS, the Downtown Park Fund also stipulates that the Recreation  
17 and Park Commission shall alone administer the development of the  
18 recreational and park facilities on any acquired property designated for  
19 park use by the Board of Supervisors, using such monies as have been  
20 allocated for that purpose at a joint meeting of both commissions; and

21 WHEREAS, the Board of Supervisors adopted Resolution #1022496  
22 approving the Mid-Embarcadero Urban Design Plan which includes an area of  
23 open space south of the Justin Herman Plaza suitable for a music concourse  
24 site; and

25 WHEREAS, the Board of Supervisors also approved resolution #566-98  
urging the Planning, Recreation and Park, Public Works and other relevant

1 City departments to develop a detailed proposal and identify funding  
2 sources to develop a music concourse at the Mid-Embarcadero; and

3 WHEREAS, the Recreation and Park Commission and the Planning  
4 Commission, meeting jointly, approved and authorized the appropriation of  
5 up to \$984,850 from the Downtown Park Special Fund for the proposed  
6 enhancements to the Mid-Embarcadero Music Concourse site located in lot  
7 numbers 1, 2, 14-16, 18 of Assessor's Block 3714, in a P (Public) Use  
8 District adjacent to the C-3-0 (Downtown Office) Use District; now,  
9 therefore, be it

10 RESOLVED, That the Board of Supervisors of the City and County of San  
11 Francisco appropriates \$984,850 from the Downtown Park Special Fund for the  
12 proposed enhancements to the Mid-Embarcadero Music Concourse site.
