13 Section 1. The Board of Supervisors hereby adopts and implements an amendment  
14 to the 2001-2003 Collective Bargaining Agreement between the City and County of San  
15 Francisco and the San Francisco Fire Fighters Union, Local 798 IAFF, AFL-CIO, Unit 1 by  
16 appending a Letter of Agreement concerning the City's 2002-2003 budget which provides: (a)  
17 for the City to reduce its "pick-up" of the required employee contribution to the retirement  
18 system by 2.75% of the employees' compensation effective July 1, 2002 through June 30,  
19 2003; (b) a 1% base wage increase effective close of business June 30, 2003 and; (c) a no  
20 layoff commitment in fiscal year 2002-2003 for employees represented by participating  
21 employee organizations.




