3 **Resolution approving the settlement of the unlitigated claim filed by City and County of**
4 **San Francisco against South Harmony Shipping, Inc. for \$65,000; claim was presented**
5 **by City on July 28, 2010.**

7 WHEREAS, the City and County of San Francisco presented a claim for costs of
8 increased public services and removal costs on July 28, 2010 against South Harmony
9 Shipping, Inc., owner of the M/T Dubai Star, a Panamanian tanker ship that spilled oil into the
10 San Francisco Bay on October 30, 2009; and

11 WHEREAS, the Office of the Controller of the City and County of San Francisco has
12 recommended settlement of said claim by acceptance of \$65,000; and

13 RESOLVED, That pursuant to Section 10.24(b) of the San Francisco Administrative
14 Code, settlement and compromise of said claim by acceptance of \$65,000 is hereby
15 approved.
