3 **Ordinance authorizing settlement of the lawsuit filed by Precious Espinosa against the**
4 **City and County of San Francisco for \$75,000; the lawsuit was filed on June 15, 2021, in**
5 **San Francisco Superior Court, Case No. CGC-21-592684; entitled Precious Espinosa v.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Precious Espinosa v. City and County
12 of San Francisco, San Francisco Superior Court, Case No. CGC-21-592684 by the payment
13 of \$75,000. The lawsuit involves alleged personal injury on a City sidewalk.
