WHEREAS, On October 9, 2017, Cal OES awarded an additional \$300,000 to the Office of the District Attorney for the Elder Abuse (XE) Program; and

WHEREAS, The total amount awarded to the Office of the District Attorney for the XE Program is \$700,000; and

WHEREAS, The purpose of the grant is to enhance the safety of elder victims of crime by providing direct services to victims, and bridge the gap between elder justice service providers and victim service providers; and

WHEREAS, The grant does not require an amendment to the Annual Salary Ordinance (ASO) Amendment; and

WHEREAS, The grant includes a required match of 20% of the project budget or \$175,000; the source of match is through volunteer hours and general funds; and

WHEREAS, The grant includes provision for indirect costs of \$58,212; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby authorizes the Office of the District Attorney to retroactively accept and expend, on behalf of the City and County of San Francisco, a grant from the California Governor's Office of Emergency Services for the Elder Abuse Program in the amount of \$700,000 to enhance elder services.
