3 **Ordinance authorizing settlement of the lawsuit filed by Cynthia Pabalate against the**  
4 **City and County of San Francisco for \$85,000; the lawsuit was filed on July 5, 2022, in**  
5 **San Francisco Superior Court, Case No. CGC-22-600530; entitled Cynthia Pabalate v.**  
6 **City and County of San Francisco, et al.; the lawsuit involves alleged personal injury on**  
7 **a City street.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Cynthia Pabalate v. City and County of  
12 San Francisco et al., San Francisco Superior Court, Case No. CGC-22-600530 by the  
13 payment of \$85,000. The lawsuit involves alleged personal injury on a City street.

14 Section 2. The above-named action was filed in San Francisco Superior Court on July  
15 5, 2022, and the following parties were named in the lawsuit: Plaintiff: Cynthia Pabalate;  
16 Defendant: City and County of San Francisco.
