1 **Section 2. Authorization to Accept and Expend Contract Funds.**


2 DPH is hereby authorized to accept and expend retroactively grant funds from the
3 California HealthCare Foundation in the amount of \$241,225, including \$21,930 in indirect
4 costs. This grant will support the "Primary Care Quality Indicators" project, to improve DPH's
5 ability to monitor and improve primary care service delivery at San Francisco General Hospital
6 and community-based clinics through expansion of an electronic disease registry.

7 DPH is further authorized to furnish whatever additional information or assurances the
8 funding agency may request in connection with this agreement, and execute any and all
9 agreements necessary to complete the transfer of funds.






