8 toll net revenue available under Assembly Bill 664 ("AB 664"), enacted in 1975 and codified in  
9 Streets and Highways Code Sections 30880, et seq.; and,


10 WHEREAS, The Municipal Transportation Agency ("MTA") is an eligible claimant for  
11 assistance under the AB 664 program; and,

12 WHEREAS, MTA has applied for \$3,753,574 of available capital assistance from the  
13 AB 664 Bridge Toll Net Revenue program for projects related to Cable Car Vehicle  
14 Renovation, Motor Coach Replacement and Rehabilitation, Paratransit Minivans, Rail  
15 Replacement, Historic Rail Car Enclosure and Bus Catalyst Devices; now, therefore be it,


16 RESOLVED, That the Board of Supervisors authorizes the MTA to accept and expend  
17 \$3,753,574 of AB 664 Bridge Toll Net Revenue Program funds for implementation of capital


