10 public premises license from Pier 28, The Embarcadero to One Tillman Place for Azul,

12 WHEREAS, The City Planning Department has verified that the area is properly
13 zoned; and recommends approval, and,

14 WHEREAS, The Police Department recommends that the liquor license
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business
17 and Professions Code, the Board of Supervisors of the City and County of San
18 Francisco hereby determines for the foregoing reasons that the transfer of a type 48 on-
19 sale general public premises license from Pier 28, The Embarcadero to One Tillman
20 Place (District 3), to Aqua Azul, LLC, for Azul will serve the public convenience and
21 necessity of the people of the City and County of San Francisco.

22 Conditions: 1) The sale and service of alcoholic beverages shall be permitted
23 only between the hours of 12 noon and 2:00 a.m. each day of the week; 2) Petitioner
24 shall regularly police the area under their control in an effort to prevent the loitering of

1 persons about the premises; 3) The petitioner shall be responsible for maintaining free
2 of litter the area adjacent to the premises over which they have control.


